- The items to be supplied should have been procured/ produced/ manufactured, packed, labelled and being sold in conformity with the provisions of relevant Acts/ Rules in force.
- To examine the credentials, the random sampling of the items will be done in accordance with established norms. The items found defective or damaged or otherwise not conforming to the given specifications will be rejected and the supplier will be liable to replace the same within specified period of time in within 15 days.
