CORRIGENDUM

N O T I F I C A T I O N

In exercise of the powers conferred by the proviso to Article 309 of the Constitution, read with Government of India, Ministry of Home Affairs order No.7/1/65-Ests.(A) dated 16th February, 1965 and in supersession of the Union Territory of Dadra and Nagar Haveli, Labour Enforcement Officer, (Group 'B' Gazetted) Recruitment (Amendment) Rules, 2012, except as respects things done or omitted to be done before such supersession, the Administrator of Dadra & Nagar Haveli and Daman and Diu is pleased to make the following rules relating to recruitment to the General Central Service, Non Ministerial Gazetted Group B post of Labour Enforcement Officer in the Union Territory of Dadra & Nagar Haveli and Daman and Diu namely:-

(1) SHORT TITLE, APPLICATION AND COMMENCEMENT:

- (i) These rules may be called the Administration of Dadra & Nagar Haveli and Daman and Diu, Labour Enforcement Officer, Non-Ministerial Gazetted Group B Posts Recruitment Rules, 2025.
- (ii) They shall apply to the posts specified in column – 1 of the schedule to these Rules.
- (iii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the various posts made on or after this date.

(2) NUMBER OF POSTS, CLASSIFICATION AND LEVEL IN PAY MATRIX:

The number of said post, its classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules: Provided that, the Administrator of Dadra & Nagar Haveli and Daman & Diu may vary the number of posts in column (2) of the said Schedule from time to time subject to exigencies of work.

(3) METHOD OF RECRUITMENT, AGE LIMIT AND OTHER QUALIFICATIONS ETC.:

The method of recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in columns 5 to 13 of the aforesaid schedule.

(4) DISQUALIFICATION:

No person (a) who has entered into or contracted a marriage with having a spouse living, or (b) who having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the service. Provided that the Administrator of Dadra and Nagar Haveli and Daman & Diu, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

(5) POWER TO RELAX:

Where the Administrator of Dadra & Nagar Haveli and Daman & Diu is of the opinion that it is necessary or expedient so to do, he may, by order, and for reasons to be recorded in writing, and in consultation with Union Public Service Commission, relax any of the provision of these rules with respect to any class or category of persons.

(6) SAVING:

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes and Scheduled Tribes, and other special categories or persons in accordance with the orders issued by the Central Government from time to time in this regard.

Promotion :

The departmental Labour Inspector in pay level-5 with six years of regular service in the grade and have successfully completed the training of at least 02 weeks in the relevant field or as prescribed by competent authority.

Note: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors shall also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service, or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

- (ii) Bachelors Degree in Law from a recognized University / Institute.

Desirable:

Two years of experience of Labour Welfare work/Industrial Relations/Personnel Management in an organization under Central/State Government/UTs or in any PSU/Autonomous or Statutory organization.

Standard Notes:

Note 1: The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: The period of deputation including (including short-term contract) including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed three years.
