No. 7-2/EC/DNH&DD/2025: Whereas, General Elections to Panchayats in the Union Territory of Dadra and Nagar Haveli and Daman and Diu were held in October/November, 2025;

And whereas, there was no contesting candidate in Ward No.4 and Ward No.7 of Galonda Gram Panchayat, Ward No.6, Ward No.7, Ward No.8 and Ward No.9 of Khanvel Gram Panchayat, Ward No.5 of Randha Gram Panchayat, Ward No.1, Ward No.2, Ward No.3 and Ward No.6 of Vasona Gram Panchayat in Dadra and Nagar Haveli District during the aforesaid General Elections;

And whereas, in pursuance of the provisions of Rule 39 (2) read with Rule 29 of the Dadra and Nagar Haveli and Daman and Diu Panchayats (Election Procedure) Rules, 2023, the Election Commission, Dadra and Nagar Haveli and Daman and Diu, vide Notification No. 7-2/EC/DNH&DD/2025 dated 9th January 2026 had called upon the aforesaid ward to elect a member each to fill the casual vacancies in accordance with the Dadra and Nagar Haveli and Daman and Diu Panchayat Regulation, 2012 and the rules and orders made thereunder;

And whereas, after the withdrawal of candidatures on 19th January, 2026, only a single candidate each was left in the fray in Ward No.3 of Vasona Gram Panchayat, Ward No.7 of Khanvel Gram Panchayat and Ward No.5 of Randha Gram Panchayat and the respective Returning Officers had declared the said candidates as elected (uncontested);

And whereas, the poll was taken on 8th February 2026 in Ward No.4 and Ward No.7 of Galonda Gram Panchayat, Ward No.6 and Ward No.8 of Khanvel Gram Panchayat, Ward No.1, Ward No.2, and Ward No.6 of Vasona Gram Panchayat ;

Whereas, after the counting of votes on 10th February, 2026 the respective Returning Officers have declared the results of the elections where poll was taken on 8th February, 2026;
