**PROCLAMATION REQUIRING THE APPEARANCE OF A PERSON ORDERED TO BE  
DETAINED UNDER THE GUJARAT PREVENTION OF ANTI-SOCIAL ACTIVITIES ACT,  
1985 READ WITH SECTION 84 OF THE BHARATIYA NAGARIK SURAKSHA SANHITA,  
2023.**

WHEREAS, a Detention Order has been made by me u/s. 3(2) of the Gujarat Prevention of Anti-Social Activities Act, 1985 (the Act) as extended to the U.T. of Dadra & Nagar Haveli and Daman & Diu that Zabbar Asif Movar, aged 31 years r/o 474 - A/2, Hajjiyawada, Diu be detained, which is deemed to be a warrant of arrest u/s.8(1) of the Gujarat Prevention of Anti-Social Activities Act, 1985 thereupon issued that the said Zabbar Asif Movar cannot be found, and whereas, it has been shown to my satisfaction that the said Zabbar Asif Movar has absconded (or is concealing himself to avoid the service of the said warranty);

Proclamation is hereby made that the said Zabbar Asif Movar, r/o 474 - A/2, Hajjiyawada, Diu is required to appear at Collectorate Office, Fort Road, Diu before me within 30 days of this Proclamation i.e. on 14<sup>th</sup> day of March, 2026.
