NOTIFICATION

In exercise of powers conferred by clause (b) of sub-section (3) of Section 79 of the Information Technology Act, 2000 (Central Act 21 of 2000) (hereinafter referred to as 'aforementioned Act') read with the first proviso to sub-clause (ii)(I) of clause (d) of sub-rule (1) of Rule 3 of the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Amendment Rules, 2025 along with Government of India, Ministry of Home Affairs, New Delhi Notification bearing S.O. 3935(E) dated 25/10/2013, the Administrator, Union Territory of Dadra & Nagar Haveli and Daman & Diu being the appropriate Government as defined under clause (e) of sub-section (1) of Section 2 of the aforementioned Act, hereby orders the following:

1. The Police Department, Dadra & Nagar Haveli and Daman & Diu to be the Nodal Agency in Union Territory of Dadra & Nagar Haveli and Daman & Diu to perform the functions under Section 79(3)(b) of the Information Technology Act, 2000.
2. The Deputy Inspector General of Police, Dadra & Nagar Haveli and Daman & Diu, to be the Nodal Officer, as per Section 79(3)(b) of the Information Technology Act, 2000.

This Notification shall supersede the Notification No. PHQ/DNH&DD/Cyber Space/Nodal Officer/2025/1064 dated 26/07/2025.
