You are hereby authorised and requested to cause the said motor vehicles to be attached by seizing of above vehicles i.e. in the manner specified in clause (a) of subsection (3) (a) of section 85, and to be held under attachment pending the further order of this Court, and to certify without delay what you may have done in pursuance of this order
