NOTIFICATION

Whereas, certain draft rules, which the U.T. Administration of Dadra & Nagar Haveli and Daman and Diu proposes to make in exercise of the powers conferred by sub-section 28(1) and read with Section 4(1) and 4(2) of the Goa, Daman, & Diu Marine Fishing Regulation Act, 1980, and Rules 1982, the Dadra and Nagar Haveli & Daman and Diu Marine Fishing Regulation (5th Amendment) Rules, 2025 are proposed to be published for inviting objections and suggestions from all persons likely to be affected thereby on or before the expiry of 30 days from the date of the publication of the said Notification in the Official Gazette;

Now, therefore, in exercise of the powers conferred by section 28(1) and read with Section 4(1) and 4(2) of the Goa, Darman, & Diu Marine Fishing Regulation Act, 1980, and Rules 1982, the Administrator of U.T. DNH & DD, hereby makes the following amendment:

1. Short title and Commencement:

(1) These rules may be called the Dadra and Nagar Haveli and Daman and Diu Marine Fishing Regulation (5th Amendment) Rules, 2025.

(8) Use of Turtle Excluder Device (TED) in Fishing Trawlers:

- (a) “Turtle Excluder Device” is a specialized device that allows a captured sea turtle to escape when caught in a trawl net”.
- (b) “In case of fishing by Trawling, no trawl net shall be used for fishing without a Turtle Excluder Device (TED) attached before the cod end of the trawl net”
