TERMS & CONDITIONS

1. The quoted rates shall be **F.O.R. Government Hospital, Daman**, inclusive of delivery, commissioning, and all other charges, and shall remain valid up to **31.12.2026**.
2. The rates should be quoted **inclusive of all applicable taxes (including GST), installation charges, configuration, testing, and commissioning charges.**
3. GST will be paid as applicable. All other taxes, duties, levies, and charges related to supply and service shall be included in the quoted rates.
4. **No additional charges** for packing, forwarding, insurance, transportation, or any incidental services will be entertained.
5. The bidder shall provide **75 Mbps dedicated (1:1) Internet Leased Line connectivity** strictly as per specifications.
6. The service provider must ensure **minimum 99% uptime** on a monthly basis.
7. **Service Level Agreement (SLA):**
 - o Complaints must be attended within **2 hours** and resolved within **4-6 hours**.
 - o 24x7 technical support must be provided.
8. The bidder shall provide at least **Five Static Public IP address**.
9. The bidder should be a **licensed Internet Service Provider (ISP)** and must submit valid supporting documents.

10. The bidder shall submit an **affidavit on non-judicial stamp paper of Rs. 20/-** stating that the quoted rates are not lower than those quoted to any Government/Semi-Government/Public Sector Organization.
11. The bidder must furnish a **Non-Blacklisting Certificate**, confirming that the firm has not been blacklisted by any Government or private organization and that no vigilance/CBI case is pending against the firm.
12. The quotation must reach this office on or before **27.04.2026 up to 3:00 PM** and will be opened on the same day at **4:30 PM**, if possible.
13. The successful bidder shall complete installation and commissioning within **2 - 3 days** from the date of issue of the work order.
14. Payment shall be made on a **monthly basis after satisfactory service** and submission of bills. No advance payment will be made.
