NOTIFICATION

WHEREAS, the Hon'ble Supreme Court of India, while hearing CONMT.PET.(C) Nos. 425-426/2015 in W.P.(C) Nos. 523-524/2002 (Justice V.S. Dave, President, The Association of Retd. Judges of Supreme Court and High Courts Vs. Kusumjit Sidhu & Ors.), through various orders dated 24.10.2018, 30.04.2019, 25.07.2019, 18.02.2025 and 29.04.2025, directed all States and Union Territories to extend post-retirement medical facilities and other benefits to retired Chief Justices / Judges of the High Courts including their spouses and dependent family members on a uniform basis;

AND WHEREAS, the Union Territory of Dadra and Nagar Haveli and Daman and Diu falls under the jurisdiction of the Hon'ble High Court of Bombay by virtue of the Dadra and Nagar Haveli and Daman and Diu (Merger of Union Territories) Act, 2019 and does not have a separate High Court. The UT Administration does not maintain service book record of the retired judges of Hon'ble High Court, nor it is the pension disbursement authority.

NOW, THEREFORE, the Hon'ble Administrator, Union Territory of Dadra and Nagar Haveli and Daman and Diu is pleased to order that the retired Chief Justices and Judges of the Hon'ble High Courts, including their spouses and dependent family members, shall be provided the following facilities on a uniform basis:

- a. All facilities at par with sitting Judges;
- b. Cashless facilities in all the Hospitals of UT Administration.
