Subject: Implementation of the provisions of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 – Constitution of Internal Complaints Committee (ICC) Regarding....

The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 is an Act to provide protection against sexual harassment of women at workplace and for the prevention and redressal of complaints of sexual harassment and for matters connected therewith or incidental thereto. Section 4 of the Act mandates the constitution of the Internal Complaints Committees in all the workplaces with ten or more employees.

2. The Hon'ble Supreme Court, has also recently, in the matter of Aureliano Fernandes vs State of Goa & Others, re-emphasized the importance of strict compliance of the provisions of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (SH Act), as under: -

- (i) To constitute Internal Complaints Committee and Local Committees in all applicable establishments;
- (ii) To take steps under the provisions of the POSH Act if no such Committee has been constituted.


3. All the private sector organisation or a private venture, undertaking, enterprise, institution, establishment, society, trust, non-governmental organisation, unit or service provider carrying on commercial, professional etc, having ten or more employees are therefore required to constitute ICC / Local Committees in accordance with the provisions of the Act.

4. All the establishments in the Union Territory of Dadra & Nagar Haveli and Daman & Diu having ten or more employees are therefore directed to comply with the provisions of the POSH Act and submit a report of compliance with the following details, to the State Mission Coordinator, Social Welfare Department, Daman (through email id [sw-dnh@nic.in](mailto:sw-dnh@nic.in) / [dycollg-dmn-dd@nic.in](mailto:dycollg-dmn-dd@nic.in)), within a period of 30 days: -

- (i) Copy of letter constituting ICC.
- (ii) Screenshot of the registration on She-Box Portal <https://shebox.wcd.gov.in>

5. Non-compliance will be viewed seriously and action will be taken against defaulter in accordance with the law.
