**ORDER**

**(UNDER SECTION 163 OF THE BHARATIYA NAGARIK SURAKSHA SANHITA, 2023)**

**WHEREAS**, the festival of Eid-ul-Zuha (Bakrid) will be celebrated on 27<sup>th</sup> May 2026;

**AND WHEREAS**, in anticipation of any untoward incident and for the maintenance of peace, harmony and tranquillity as well as the prevention of potential disturbances to law and order that may endanger lives and property, it is imperative to issue a prohibitory order;

**NOW, THEREFORE**, in the exercise of the power conferred upon me by Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023, and to maintain peace and tranquillity, **I, Saurabh Mishra, IAS, District Magistrate, Daman**, do hereby make this written order that there is:


- (A) Ban on sacrificing any bovine or prohibited animal.
- (B) Ban on sacrificial proceedings in all public areas, including but not limited to (a) Public roads and footpaths, (b) Inside and outside the premises of hospitals/nursing homes, (c) Inside/Outside the premises of educational institutions like schools and colleges, (d) Inside and outside the premises of the temple/mosque/religious institutions, (e) Inside or outside parks or other public places.
- (C) Ban on carrying meat or carcass openly in public places.
- (D) Ban on offering prayers on roads or footpaths.
- (E) Prohibition of activities inciting communal violence, carrying weapons, disturbing peace, and excessively high-volume microphones.

This order shall come into force with immediate effect from 27/05/2026 to 30/05/2026.

Any person contravening this order shall be punishable under section 223 of the Bharatiya Nyaya Sanhita, 2023.
