NOTIFICATION

Whereas, the draft Town Planning Scheme 04A (Nani Daman) was published in the Official Gazette vide Notification No. PDA/DMN/Appr. TPS/230/2025/1727 dated 11/02/2026 for inviting objections from owners of the plots within the areas covered under draft Town Planning Scheme 04A within 60 days from the publication of the Gazette Notification.

Whereas, the Planning and Development Authority conducted a public hearing of the landowners who had submitted their objections in writing within the stipulated time. The authority considered the objections received and made modifications in the draft Town Planning Scheme 04A (Nani Daman) as per the provision of sub-section (1) of Section 68 and submitted the modified draft Town Planning Scheme as per sub-section (2) of Section 68 of the Dadra Nagar Haveli and Daman and Diu Town and Country Planning Act, 1974 to the Government for approval.

Whereas, the Government has duly approved the Town Planning Scheme 04A (Nani Daman) as required under sub-section (3) of Section 68 of the said Act.

Whereas, the Planning and Development Authority, Daman, hereby publishes the Town Planning Scheme 04A (Nani Daman) and informs the general public that the same are available for inspection at the following places:
