2. BACKGROUND & OBJECTIVE

The Directorate of Medical and Health Services ,U.T. Administration of Dadra & Nagar Haveli and Daman & Diu, is about to operationalise a state-of-the-art100-Bedded World Class Government Ayurvedic Hospital at Silvassa. To integrate holistic wellness, therapeutic rejuvenation, and traditional Ayurvedic hydrotherapy/massage therapies for both hospital patients and external wellness seekers, the Administration intends to license out a dedicated built-up space within the hospital premises to a qualified, experienced, and reputable professional agency on a monthly rental basis.

The objective is to establish a high-end, hygienic, and authentically managed Ayurvedic Spa & Wellness Centre that adheres to NABH standards, promoting holistic healthcare, medical tourism, and traditional wellness therapies.

The hospital aims to deliver quality Ayurvedic healthcare services with emphasis on patient care, cleanliness, infection prevention, nutrition, therapeutic healing environment, and efficient hospital management.

4. SCOPE OF WORK FOR THE AGENCY

- The successful bidder/agency shall be responsible for the following:
- a. **Interior Fit-Out & Ambience:** Interior aesthetic embellishment, installation of specialized Ayurvedic therapy tables (Droni), steam boxes, relaxation lounges, and aromatherapy/spa fixtures at its own cost, without structural alterations to the hospital building.
  - b. **Services Allowed:** Classical Ayurvedic wellness therapies, rejuvenation therapies, hydrotherapy, detox therapies, reflexology, body polishes, herbal steam baths, and therapeutic spa rituals under expert supervision and wellness consultations.
  - c. **Prohibited Activities:** The Licensee shall not undertake any clinical or medical treatments reserved for the Government Hospital, sell unauthorized products, sub-let or transfer the licensed premises, permit cross-gender massage/therapy services, or engage in any activity that is illegal, unethical, or in violation of applicable laws, Government guidelines, or the terms of the Agreement. Any such violation shall constitute a breach of contract and may lead to termination of the agreement and other legal action.
  - d. **Staffing Requirements:** Deploying qualified and certified Panchakarma therapists, spa masseurs, aesthetic experts, and administrative staff. All staff must possess formal

certification from recognized institutes (e.g., BAMS, Diploma/certificate in Ayurvedic Nursing/Therapy).

- e. **Consumables & Products:** Utilizing only high-grade, GMP-certified Ayurvedic oils, herbs, and spa formulations. No prohibited, synthetic, or non-compliant chemical products shall be used.
- f. **Hygiene & Quality Maintenance:** Maintaining pristine cleanliness, linen sterilization, bio-medical waste segregation (if applicable), and compliance with NABH / AYUSH safety protocols.
- g. **Utility Charges:-** The electricity, water and other utility charges for the licensed premises shall be borne by the agency.
- h. **Tariff Structure:** Offering competitive tariff rates.

6. BID EVALUATION & SELECTION METHODOLOGY

The selection will be conducted through a **Two-Bid System (Highest Financial Rent Bidding - H1)** among technically qualified bidders:

- 1. **Stage 1 (Technical Evaluation):** Technical bid (signed and stamped tender document along with mandatory documents needs to be uploaded online). Scrutiny of document submissions, past performance, turnover certificates, and staff qualifications. Hospital inspection committee may inspect existing premises operated by the bidder.
- 2. **Stage 2 (Financial Evaluation):** the bidder shall submit the overall cost excluding taxes in the online financial bid only. Financial bids of only those bidders who clear Technical Evaluation will be opened. The bidder offering the **Highest Monthly License Fee (Rent)** above the Minimum Reserve Rent of ₹ 23,444/- per month in E- Forward auction shall be declared as the Successful Bidder (H1).

**Award of Tender:-** The bidder quoting Highest Monthly License Fee (Rent) will be decided on the basis of highest cost (lump sum cost) offered subject to fulfillment of tender conditions and technical specifications.

**Note:** In case of a tie in the H1 financial bids, the bidder with higher average financial turn over the last 3 financial years shall be selected.

7. NABH & AYUSH COMPLIANCE REQUIREMENTS

Given that the Centre operates within an accredited/accreditation-track Government Ayurvedic Hospital, the Concessionaire shall be contractually bound to comply with the following, throughout the contract period:

- Adherence to the applicable National Accreditation Board for Hospitals & Healthcare Providers (NABH) standards for Wellness Centres/AYUSH facilities, including (as relevant) Facility Management & Safety, Hospital Infection Control, Care of Patients, Patient Rights & Education, Human Resource Management, and Continuous Quality Improvement chapters.
- Obtaining NABH accreditation/certification for the Wellness Centre in its own right within 18 months of commencement of operations, and maintaining such accreditation for the remainder of the contract period (including extensions); failure to do so shall be treated as a material default, without prejudice to continued compliance with all underlying standards.
- Deployment of only AYUSH-qualified/certified therapists and consultants, as detailed in Section 5, with documented competency records maintained on site for inspection.
- Use of only GMP-certified/AYUSH-licensed products and formulations, with batch/traceability records maintained and produced on demand.
- Documented Standard Operating Procedures (SOPs) for each therapy offered, informed consent from clients prior to any therapy, and a client grievance/feedback redressal mechanism.
- Fire safety, electrical safety, and structural safety compliance certificates for all fit-out and equipment installed by the Concessionaire.
- Periodic health screening of therapists/staff for communicable diseases, and maintenance of hygiene records, to the satisfaction of the Hospital's Infection Control Committee.
- Submission of a quarterly compliance report to the Hospital Administration/NAM Programme Management Unit, and cooperation with periodic inspection/audit by the Hospital's Quality/Infection Control Committee and by NABH assessors, as applicable.

## 8. KEY TERMS & OPERATING CONDITIONS

---

- a. The Director (Medical & Health Services), DNH & DD invites online bids through E-Tender portal for the work of Selection of Specialized Agency for Allotment of Space on Rent/Lease basis to Operate, Manage, and Maintain a World-Class Ayurvedic Spa & Wellness Centre at Government Ayurvedic Hospital, Silvassa”. The Period of contract will be of one (01) year, which can be extended for further 2 years, one (01) year per time, 5% annual enhancement on the base monthly license fee, terms and conditions based on performance of bidder and/or further decision by the Authority.
- b. To obtain first-hand information on the assignment and on the local conditions, the Service Provider/ Agency is advised to pay a visit to the project site before submitting a proposal if any. The Service Provider/ Agency must fully acquaint himself of local and site conditions and take them into account in preparing their proposal failing which deemed provisions shall be applicable.
- c. The proposal must be properly signed as detailed below:
  - (a) By the proprietor in case of a proprietary firm;
  - (b) By the authorised partner holding the Deed of Partnership in case of a firm in partnership (A certified copy of the Deed of Partnership shall accompany the proposal); and
  - (c) By a duly authorized person holding the Power of Attorney in case of a Limited Company or a Corporation (A certified copy of the Power of Attorney shall accompany the proposal).
- d. **BID VALIDITY PERIOD (DAYS):** 225 Days from the date of opening of Financial Bid.
- e. In the event of violation of any contractual or statutory obligations by the Service Provider / Agency, the Service Provider / Agency shall be fully and solely responsible for the same. Further, in the event of any action, claim, damages, suit initiated against the Department by any individual, agency or government authority due to acts of the Service Provider / Agency, the Service Provider / Agency shall be liable to make good/compensate such claims or damages to the Department. As a result of the acts of commissions and commissions by the Service Provider / Agency, if the Department is required to pay any damages to any individual, agency or government authority, the Service Provider / Agency would be required to reimburse to the Department such amount along with other expenses incurred by the Department, or Director (Medical and Health Services) DNH &DD reserves the right to recover such amount from the amount of security deposit of the Service Provider / Agency lying with the Institute.
- f. **Security Deposit / Performance Guarantee:** The successful bidder shall deposit an interest-free Performance Security Deposit equivalent to 6 months of the quoted monthly rent in the form of a Bank Guarantee / Fixed Deposit Receipt before signing the agreement.
- g. **Sub-leasing Prohibited:** The licensed space shall strictly be used by the selected agency and cannot be sub-leased, under-let, or assigned to any third party.
- h. **Code of Conduct & Discipline:** High standards of decorum, professional ethics, and security must be maintained. The hospital environment must be respected; loudnoise, alcohol, drugs, or illegal activity will Lead to immediate cancellation and police action.
- i. **Working Hours:** Operating hours shall generally be from 07:00 AM to 08:00 PM,

aligned with hospital administration guidelines.

- j. **Penalties for Deficiency in Service:** A penalty ranging from ₹ 2,000 to ₹ 10,000 per instance may be imposed for cleanliness lapses, uncertified staff usage, or consumer complaints.
- k. **Termination Clause:** Either party can terminate the agreement by giving 3 months' written notice. The hospital administration reserves the right to terminate the license with 15 days' notice in case of breach of agreement or statutory violation.
- l. In the event of the Service Provider / Agency failing to perform the terms and conditions of the agreement or causing any loss to the Government, the Performance Guarantee shall be forfeited without prejudice to other remedies available.
- m. The successful Service Provider / Agency shall execute an agreement with the Department of Health and Family Welfare, DNH&DD. Terms and conditions, payment terms and mode of payment, price bid documents, letter of acceptance and the agreement shall form the contract document.
- n. Tender shall not make conditional offer and if made, will be deemed as non-acceptance of the tender conditions and same shall be summarily rejected.
- o. The Department of Health and Family Welfare, DNH &DD shall not be responsible for death, injuries, etc. to the persons engaged by the Service Provider / Agency which may arise out of and in the course of their duties at Ayurvedic Hospital, Pati. The Department of Health and Family Welfare, DNH &DD shall also not be liable to pay any damages or compensations to such persons and in case the department is made or required to pay any damages or compensations to such persons, the Service Provider / Agency shall be liable to reimburse the said amount to the Department of Health and Family Welfare, DNH &DD.

## 9. ARBITRATION:

---

- a. In case of any kind, such question/difference arising under this contract in connection therewith, the same shall be referred to the sole arbitrator of Department of Health and Family Welfare, DNH&DD or any person nominated by him. The venue of the arbitration proceeding shall be the office of the Director (Medical & Health Services) or any other place as the Arbitrator decides.
- b. The performance of the Service Provider / Agency may be monitored and evaluated by committee duly constituted of the Department of Health & Family Welfare, DNH &DD. In case of any serious lapse in service delivery shall attract penalties as specified in the tender conditions and as determined by the competent authority. Continuous poor performance for 10 days together shall result in termination of the Contract on recommendation of the committee without giving any additional notice.
- c. **Jurisdiction:** - Only the courts at DNH shall have jurisdiction in respect of any matter(s) relating to or arising out of this Tender / Contract.
