ORDER

WHEREAS, the U.T. Administration of Dadra and Nagar Haveli and Daman & Diu is of the opinion that an Industrial dispute exists between M/s. Prism Industries, Bldg. 'B' Survey No. 770, Behind Maharani Udhyog Estate, Somnath Road, Dabhel, Daman and its employees Shri Sanjay Kumar and Shri Hiralal alias Harivansh Kumar Singh in respect of the matter specified in the Third Schedule annexed hereto (hereinafter referred to as the 'said dispute');

AND WHEREAS, the Administration of Dadra and Nagar Haveli and Daman & Diu considers it expedient to refer the said dispute for adjudication;

NOW THEREFORE, the sanction of the Labour Commissioner, Daman, in exercise of the powers conferred by clause "d" of sub-section 1 of section 10 of the Industrial Disputes Act, 1947, is hereby conveyed to forward the Conciliation Failure Report and to refer the said dispute to the Industrial Tribunal for adjudication.

- (i) Whether the demands of the applicants Shri Sanjay Kumar and Shri Hiralal alias Harivansh Kumar Singh for an amount of Rs. 1133154.50 (Rupees Eleven Lakh Thirty Three Thousand One Hundred Fifty four and Fifty Paise only) and Rs. 184800.00 (Rupees One Lakh Eighty Four Thousand Eight Hundred only) respectively towards the legal dues like Gratuity, Pending wages, Leave Salary etc. are justified? If no, what relief the workmen are entitled to?
