

ASSESSMENT CAMP CUM AWARENESS PROGRAM (2nd Phase)

at

Dimoria H.S School, Bherakuchi, Dimoria Block, Kamrup Metro, Assam on 14.06.2025

Composite Regional Centre for Skill Development, Rehabilitation, and Empowerment of Persons with Disabilities (CRCSRE) – Guwahati (under the administrative control of SVNIRTAR, Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment, Government of India) conducted a pilot basis ASSESSMENT CAMP CUM AWARENESS PROGRAM (2nd Phase) for persons with Disabilities (Divyangjan) in collaboration with Directorate of Social Justice & Empowerment, Govt of Assam, Office of the District Social Welfare Officer & CDPO office Demoria.

The venue of this program was Dimoria H.S School, Bherakuchi, Dimoria Block, Assam. The targeted beneficiaries were from Six Gram Panchayats (GP) out of total 12 GPs. As per census 2011 total population of this BLOCK was 150489. The six GPs were covered in this phase namely Helagog, Durung, Tapatoli, Khetri, Ouzari, Dhopguri and other 6 GPs has been already covered during 1st phase in the month of March, 2025.

The program was conducted in two part, in first part there was inaugural session followed by awareness generation and in second part assessment of PwDs were done by various professionals of CRC Guwahati.

During the inaugural session Chief Guest Shri Madan Amchi, President of School Development & Management Committee and Dimoria Raja President, Shri Hare Krishna Sarkar, Head master, Dimoria HS school, and Dr Dipak Kumar Aich, Asst. Professor Special Education, CRC Guwahati were remain present and grace the occasion.

In Awareness generating part total 99 participants including Anganwadi workers, Supervisors, parents/guardians of PwDs were present. The main focus was to aware them about their important role in identifying different types of disabilities as per RPWD Act 2016, on this session was taken by Mrs Pinaki Medhi, Occupation Therapist, CRC Guwahati. Next session was taken by Mr Raj Kamal Pandey, Rehabilitation Officer, CRC Guwahati about rights of PwDs, various Government of India sponsored schemes and facilities available for the Divyangjan as per different age groups and how the CRCSRE-Guwahati is providing all these services to them in entire Assam.

In assessment part, total 160 Divyangjans have been assessed under different sections viz. UDID (83), Skill Development (29), NDFDC Loan (4), NIRAMAYA (5), P&O & ADIP (77), Speech & Hearing (45), O&M (21), PT (79), OT (73), Special Education (58), Clinical Psychology (26).

The focus of the pilot project (phase-2) was to analyze the feasibility to sensitise community and village health associates and door to door service on the same day. This program was organized in collaboration with the Directorate of Social welfare, Ministry of Social Justice, Govt of Assam, and supported at the ground level by Local CDPO, Supervisors, AWWs.
