The purpose of this MoU is to provide quality services and support care, and to reach out to more vulnerable children with disability in the North Eastern Region by collaborating in the areas of mutual interest. The partnership goals of the joint efforts are to collaborate in disseminating information regarding rehabilitation, care, and other services provided at the CRC and NIPCCD; undertaking collaborative research project of mutual interest; sharing expertise and resources in terms of infrastructure and human resources for training; providing platform for clinical exposure, fieldwork and internship placement for the students of the courses run by CRC and NIPCCD/MWCD; conducting CRE/CME/STT/Seminar/Workshop/Training and webinar on topic mutually agreed upon without any commercial or financial implications.

Lenka, Director on behalf of CRCSRE, Guwahati, and Dr. Ritu Geu Goswami, Deputy Director on behalf of NIPCCD, Guwahati in presence of their faculty members of NIPCCD, Guwahati.
