

**“SAMADHAN SAMAROH”- A SPECIAL LOK ADALAT BY THE SUPREME COURT OF INDIA**

**Frequently Asked Questions (FAQs)**

**1. What is the “SAMADHAN SAMAROH 2026”?**

With the aim of making justice simple and accessible to every household, and encouraging people to resolve disputes together by agreeing on a solution, the Supreme Court of India is organizing ‘SAMADHAN SAMAROH 2026’. The initiative will commence on 21<sup>st</sup> April 2026 and conclude with a Special Lok Adalat on 21<sup>st</sup>, 22<sup>nd</sup>, and 23<sup>rd</sup> August 2026.

**2. What is the objective of the “SAMADHAN SAMAROH 2026”?**

The aim of this SAMADHAN SAMAROH 2026 (Special Lok Adalat) is to help settle suitable pending cases in the Supreme Court through agreement between both parties.

**3. Where will the Special Lok Adalat be held?**

The Special Lok Adalat will be held at the Supreme Court of India.

**4. Which cases will be taken up?**

Cases pending before the Supreme Court, like Matrimonial Disputes, Accident Claim Cases, Cheque Bounce Cases, Land Acquisition Disputes, Criminal Compoundable Cases, Labour Law Disputes, and other cases that are suitable for mutual agreement and settlement, will be taken up.

**5. How can a case be included in the SAMADHAN SAMAROH 2026 - Special Lok Adalat?**

A request to include the case can be made through the easy-to-fill Google Form available on the website of the Supreme Court of India.

**6. Where is the Google Form available?**

It is available on the website of the Supreme Court of India (<https://www.sci.gov.in>).

**5. Will my case be settled in the SAMADHAN SAMAROH 2026 - Special Lok Adalat with my consent?**

Yes, it is a voluntary process, and your case will be settled only with the consent of both parties.

**6. Will a meeting be conducted to try to reach a settlement for my case?**

Yes, meeting(s) to try to reach a settlement in your case will be conducted before the Special Lok Adalat.

**6. Where will the settlement meetings take place?**

For trying to reach a settlement for your case, meetings will be conducted at the mediation centres of Legal Services Authorities at the State, District, Taluka and also at the High Court levels.

**7. Who will assist in these settlement meetings?**

Trained mediators and officials of Legal Services Authorities will assist in reaching a settlement during these meetings.

**8. Do parties have to appear in person during these meetings?**

Parties may participate physically or virtually in these meetings.

**9. What will happen during the meetings conducted for reaching a settlement?**

Efforts will be made to find a solution through mutual consent and dialogue during the meetings.

**10. Who can participate in the meeting conducted to reach a settlement?**

Parties of the case and their Advocates can take part in the meeting.
