Regulations

Classification and Enlistment of Contractor in the Uttarakhand Peyjal Nigam

Regulations : 1- These regulations will govern the classification and enlistment of contractor in the U.K. Peyjal Nigam. The tenders of only those contractors will be considered for any work in the Uttarakhand Peyjal Nigam, who are enlisted to tender for that work according to their enlistment. Issue and receipt of applications for enlistment will remain open from the on 1st February to 31st of March every year without late fee. Application form will be issued throughout year. Application form for enlistment submitted after 31st March will be received with late fee from 1st April to 31 August @Rs. 500/- per month or part the roof and from 1st September to 31st January @ Rs. 1000/- per month part the roof. The cost of application form for enlistment in duplicate with one copy of the (Regulations) will be available on payment of **Rs. 500/+Trade Tax/Vat as applicable+ Rs. 50/-** postage charges (if required by post) by money order/cash in the name of the Enlisting Authority.

Enlisted contractors are allowed to work in the area and category in which they are allowed, However notices inviting tenders shall be published in at least two daily News papers including one in local News paper circulated in Uttarakhand. In case the tenders of having estimated amount less then for which publication of tender notice in News paper is not mandatory, the tender notice will be placed on tender notice board of the Division/ Unit inviting tender and copies of notices inviting tenders shall invariably be sent to them at their registered address free of cost by ordinary post for the works falling in the category in which they are enlisted.

The contractors shall be allowed to work in their category and area of works specified in their class in which they are enlisted. However, contractors enlisted in Water Supply Works under Pipe Line Category shall be allowed to tender of the small clear water, Reservoirs upto 50 K.L. capacity and Small Building works which are included in the tender of Pipe Laying works upto 25 Lacs. The Electrical contractors who hold a valid license of category "A" from chief Electrical inspector will be enlisted in 'A' class and those who hold the license of category 'B' will be enlisted in 'B' and 'C' class.

Only the enlisted contractors/ firms in Uttarakhand Peyjal Nigam are allowed to work within the scope and limit of the category in which enlisted however all Central/State Govt. agencies including public undertaking are exempted from enlistment under these regulations.

REGULATIONS – 2 (1) Enlistment of contractors will be according capacity for the following categories which will be further classified as in appendix-A. For Class-A, Class-B & Class-C However for Class-D. The category will be as specified below in 2(1)a.

1- Water Supply Works.

- (a) Over Head Tank
- (b) Pipe Laying
- (c) Tube Wells
- (d) Deep well hand Pumps
- (i) Deep well Hand Pumps (Hand Boring)
- (j) Deep Well Hand Pumps (Rig Machine)

2- Sewerage Works

(a) Sewer Laying, Sewage Channel, Stone water drainage & Appurtenant Works.

3- Building Works Including Roads. (Only for Water supply and sewage scheme).

4- Electrical & Mechanical Works Including supply & installation of Pumping Plant.

5- Intake works/Clear Water Reservoir/ Sewage Pumping Station/Water Supply Pumping Station.

6- Water Treatment

7- Sewage, Waste Water & Industrial Waste Treatment

8- Turnkey Projects.

- (a) Water Supply
- (b) Sewerage.

2. Each category of contractors will be further classified as in appendix according to the upper financial limit to the works for which a contractor is enlistment in the particular class to tender.

Who are to
enlisted

REGULATION-3 Enlistment in all classes will be open to all individuals undivided Hindu families, firms registered under the Indian partnership Act. And public or private limited companies.

PROVIDED that an applicant will be enlisted only in that class in which found suitable in accordance with these regulations by the authority prescribed herein for the purpose and the enlisted party shall be called contractor for the purpose of these regulations.

Qualification
for enlistment

REGULATION-4 An applicant for enlistment to a particular class should for have a minimum solvency as mentioned in Appendix 'B', technical staff as mentioned in Appendix 'C' and equipment tools and plants as mentioned in Appendix 'D'. He should have satisfactorily executed at least five works whose individual value should at least be as mentioned in Appendix 'E' and must not be involved in offence of an offence involve mg moral turpitude.

However if a contractor does not have experience as required in Appendix 'E' but fulfills all other conditions for enlistment, Will be enlisted provisionally under the lowest class of the concerned category for period of two years. This period of probation can be extended by one year on special grounds by Managing Director/ Chief Engineer.

Proof of applicant's solvency

REGULATION-5 (1) In case of individuals firms and Undivided Hindu families, proof of the solvency of the applicant will consist of a certificate signed by the Distt. Magistrate concerned or a certificate reference of a Scheduled Bank.

(2) In the case of a private or public limited company the proof of the Company's solvency will be its last balance sheet audited and certified by a Chartered Accountant or a certificate/reference of a Scheduled Bank.

Proof of employment of technical staff

REGULATIONS-6 Proof of employment of the required technical staff will be consist of a declaration by the applicant in the form as per Appendix 'M' in the presence of a Notary public prosecutor giving full particulars of the required staff.

Proof of Possession of machinery & tools etc.

REGULATIONS-7 Proof of possession of required Machinery & tools and plants will consist of a declaration by the applicant in the from as per Appendix 'N' made in the presence of Stipendiary Magistrate giving full particulars of the equipment or an Affidavit for the same verified by a Notary public prosecutor.

Previous Experience

REGULATIONS-8 Evidence of satisfactory execution of five work of the required value will consist of certificate from the Engineer-in-charge of the works not below the rank of an Executive Engineer either of a Central/State Govt. Department or Central/State Govt. Public sector undertaking or Central / State Govt. Local bodies such as Jal Sansthans/ Municipal Corporation / Development authorities related with water supply, Sewerage or Public Health Engineering Department. The Experience Certificate must be on official dispatched letter from the issuing authority.

Moreover the experience certificate must be for the work which the contractor/firm has executed within last 10 yrs.

REGULATIONS-9 (1) The application for enlistment will be made in the form given in Appendix 'F' and shall be accompanied by a demand draft of the registration fee mentioned in sub-para (2) and documents mentioned in sub para (3) A separate application will have to be made for different categories of works. The money receipt for the application form should also be attached with the application.

(2) The registration fee should be as under :-

- (3) Every application shall be accompanied by the following document
 - I. Proof solvency of the applicant.
 - II. Proof of employment of the required technical staff .
 - III. Proof of possession of required machinery, tools and plant
 - IV. proof of execution of five works of the required value.
 - V. In case of a firm duly certified copy of the partnership deed and registration certificate and in case of a company the deed Articles of Association.
 - VI. Character Certificate as per Appendix 'L' having one attested copy of photography on the body of certificate with two extra copies.

(4) In case of any change in solvency technical staff, tools and plants as mentioned in Regulation-4 above, or Articles of Associate Constitution of a company as mentioned in Regulation-9 (3) above the same shall be intimated to the authority competent for enlistment in the 7 days of such change and an acknowledgement of the same shall be obtained.

REGULATION-10 An Application for Enlistment to a particular class of Contractor, will be presented to the authority mentioned in Appendix 'G' who will be the final authority in the matter, subject to the provisions of appeal and review made hereafter.

REGULATION-11 Enlistment will entitle the contractor to tender for works within the jurisdiction of the authority who ordered enlistment.

REGULATION-12 (1) The authority to whom an application for enlistments is presented may get such enquiry held as he considers necessary before passing the final orders. If the authority is satisfied that the applicant is suitable for being enlisted in the class applied for he will pass an order to this effect This order, will however be provisional and will become final only after the contractor has deposited the security provided in Appendix 'H' If the authority is not satisfied then he will pass an order rejecting application giving reasons of there and intimate the applicant in writing within 15 days of such rejection order. The applicant can there after file an appeal against the rejection order, before the next higher authority, who will dispose it off, ordinarily, within three month.

(2) All applications shall, ordinarily, be disposed off within three months of the date of presentation.

(3) A Contractor whose application for enlistment has been rejected shall not be entitled to apply a fresh for enlistment within 6 months of the date of the final order passed in the case.

General
Security

REGULATION-13 (13) A General security as mentioned in Appendix 'H' shall be deposited by the contractor within one month of

the receipt orders of enlistment or within such period not exceeding three month as may be extended by the authority ordering enlistment. If no such security is deposited the order of enlistment will be deemed to have lapsed and the matter will be finally closed.

(2) The General Security may be in one of the forms as specified in para 71 of Financial Hand Book Vol. V part, I amended from time to time.

(3) The contractor will then become entitled to tender for works allowed by Regulation-11 above. He will have to deposit earnest money as provide in tender documents. After acceptance of tender the contractor will have to deposit security money for due fulfillment of the contract as specified in tender. The amount of earnest money and security money and its mode of deposit will be provided in tender document which shall be pledged to the tendering authority in accordance to the provisions of F.H.B. Volume -5 and 6 and orders issued by U.K. Government/ U.A. Jal Nigam from time to time.

(4) Recovery of any amount due from contractor in respect of any work if required shall be made from the General Security also to the extent of available amount.

(5) The general security may be refunded to the contractor on the expiry of a period of 6 month from the removal of his name from the Register of Classified Contractors.

REGULATION-14 (1) The contractor shall have to keep the staff at the site of work as per Appendix 'C' attached.

(2) If the contractor fails to comply with sub-regulation (1), The Engineer-in-charge of the work shall report the matter to The listing enlisting authority of the contractor, who after giving the opportunity to the contractor to explain as may be considered necessary, orders the removal of the contractor's name from the Register of Classified Contractors. This may be an addition to any action which may be taken against the contractor in terms of his contract for the work.

REGULATION-15 (1) The authority competent to enlist a contractor or any higher authority having jurisdiction may order the removal of a contractor's name from the Register of enlisted contractors for the reasons to be mentioned in the order and communicated to the contractor. Before such order is passed the contractor shall be served with a show cause notice giving reasons for the same and given a reasonable opportunity to explain the reasons among the followings.

- I. Unsatisfactory execution of work after tender is accepted.
- II. Failure to commence work when tender is accepted.

- III. Failure to maintain required capital, technical staff, machinery tools and plant.
- IV. Failure to maintain the required amount of general security.
- V. Conviction of an offence involving moral turpitude.
- VI. Persistent misconduct by him-self or his employees.
- VII. Habitual indebtedness.
- VIII. Bad reputation in market.
- IX. Neglecting quality and offering sub-standard work/materials.
- X. Unsystematic working.
- XI. Neglecting timely accounting of stores supplied by the Nigam misappropriation of stores.
- XII. Speculative bidding.
- XIII. Black listed by Nigam or any other sister organizations of Uttarakhand.
- XIV. Being an un discharged insolvent.
- XV. Having unsound mind
- XVI. Holds any office of profit under the Nigam.
- XVII. The period for which he was previously removed from the list of approved contractors has not passed or exemption has not been granted by the Managing Director.
- XVIII. Bring/Carrying of arms and ammunitions in the premises, where tenders are schedule to be received and opened.
- XIX. Any other act which in the judgment of the authority to order the removal of the name from the list, is undesirable or amounts to misconduct.
 - (2) The officer ordering the removal will inform all authorities below him to make a note to this effect against the name of contractor in their registers.
 - (3) Such order of removal unless passed by the Managing Director/Chief Engineer will not have effect in the areas(s) not controlled by the authority ordering the removal.

Appeal
review

REGULATION-16 : An Applicant of enlisted contractor who feels aggrieved by any order passed under these regulation, may file an appeal to the next higher authority within a period of one month of receipt of intimation of such order and the order passed by the such authority after holding such enquire as it may consider necessary, shall

be final. Such appeals shall ordinarily be disposed of within a period of two month.

Provided that no appeal shall lie against an order passed by the Managing Director/Chief Engineer, However the person aggrieved by the said order may apply to Managing Director for a review within the period specified above and the Managing Director may pass any order considered suitable.

Register of
classified
contractors

REGULATION-17 : (1) All authorities competent to enlist contractors and all Assistant Engineers shall maintain a register of classified constrictors in from mentioned in Appendix 'I' Separate registers will be maintained for different categories. Under each category separate pages will be allotted for contractors of different classes.

(2) In this register names of the contractors will be entered under the class in which the contractor is ordered to be enlisted other by the authority maintaining the Register or by any higher authority having jurisdiction.

For this purpose orders of enlistment, which have become final after deposit of general security shall be communicated by the authority concerned to all offices below him.

Certificate of
enlistment

REGULATION-18 : (1) The authority competent, enlist a contractor in the form mentioned in Appendix 'J' after the order of enlistment has become final on deposit of general security.

(2) The enlistment will be valid for & period of three years from the date of registration.

(3) Within two months before expiry of the certificate of enlistment, the contractor will apply for renewal of the certificate to the authority competent to enlist a contractor of that class and under his jurisdiction, in the form mentioned in Appendix 'K' together with required documents including character certificate.

Contractors who are registered before the revision of this regulation will have to submit certificate of satisfactory execution of five works and solvency of the amount mentioned in this revised regulation while applying for first renewal after revised regulation come into force. The authority concerned will than issue fresh certificate of enlistment valid till the end of the next years. The fees for renewal shall be the same as for Registration and shall have to e deposited with each renewal. However if contractor falls to submit his renewal application as referred above within stipulated period, he will be liàble to pay a fine @ 500/- per month or part there of up to six months and Rs. 1000/- per month or part there of for the remaining six months. If contractor fails to apply for renewal during one year, his registration will be treated as cancelled and he will have to apply for fresh new registration. Fresh Certificate of enlistment issued after renewal will remain valid for three years from the expiry date of old registration.

(4) Duplicate certificate of registration may be issued in case where they are lost or destroyed due to an accident or any other valid reason the application for a duplicate copy should be submitted with in from the date on which it has been lost. The following fee will be a week charged for the issue of the duplicate copies.

A. Class contractors	Rs. 150

(5) In case of a firm (s) and private and Public Limited Companies an Individual should be authorized to deal with the department on their behalf issue on production of power of Attorney.

General Regulation -19

With the concurrence of Finance Director U.K. Peyjal Nigam the Chief Engineer in charge of centralized purchase at Head Office Peyjal Nigam shall have the authority to revise and update the cost of application forms for registration postage charges, registration and its renewal fees etc. and other financial figures given any where in the regulation.
