THE CONSTITUTION (FORTY-NINTH AMENDMENT)
ACT. 1984

[11th September, 1984.]

An Act further to amend the Constitution of India.

BE it enacted by Parliament in the Thirty-fifth Year of the Republic of India as follows:-

- 1. Short title and commencement.-(1) This Act may be called the Constitution (Forty-ninth Amendment) Act, 1984.
- (2) It shall come into force on such date_669 as the Central Government may, by notification in the Official Gazette, appoint.
- 2. Amendment of article 244.-In 244 article the Constitution, in and (2),"and clauses (1) for the Meghalaya", words the words ",Meghalaya and Tripura" shall be substituted.
- 3. Amendment of the Fifth Schedule.-In the Fifth Schedule the to Constitution, in paragraph 1, for the words "and Meghalaya", the words ",Meghalaya and Tripura" shall be substituted.
- 4. Amendment of the Sixth Schedule.-In the Sixth Schedule to the Constitution,-

- (a) in the heading, for the words "and Meghalaya", the words ", Meghalaya and Tripura" shall be substituted;
- sub-paragraph (1) of paragraph I, for the words and "Parts I Π", the words, figures letter "Parts I,II and IIA" and and shall be substituted;
- (c) after paragraph 12A, the following paragraph shall be inserted, namely:-
- "12AA. Application of Acts of Parliament and of the Legislature State of Tripura to the autonomous district and autonomous regions in the State of Tripura.-Notwithstanding anything in this Constitution,-

- (iii) after sub-paragraph (2), the following sub-paragraph shall be inserted, namely:-
- The reference in Part IIA in "Tripura `(3) the table below to the District" Tribal shall reference Areas be construed as a to the comprising tribal the First Schedule territory the areas specified in to the Tripura Tribal Areas Autonomous District Council Act, 1979.';
- (f) in the Table, after Part II and the entries relating thereto, the following Part shall be inserted, namely:-
