# VACANCY CIRCULAR

It is proposed to fill up two post of Proof Reader in the Legislative Department, Ministry of Law & Justice in PB-1 of Rs.5200-20200/- plus Grade Pay of Rs.2800/- on deputation/absorption basis. One post is to be filled up on deputation basis and one post is to be filled up on deputation or absorption basis. The post belongs to General Central Service, Group "C" (Non-gazetted, Ministerial).

2. The eligibility criteria for the post are as under:-

Persons working in similar or equivalent grade on regular basis in Central Government Offices or Government of India Presses and possessing educational & other qualifications as under:-

### Essential:-

- A Degree of a recognised University incorporated by or under a Central Act: Provincial Act or a State Act or any institution for higher education deemed to be a University by the Central Government or any other institution or foreign University approved by the Central Government.
- (ii) Minimum five years' experience of Printing work in English in the Ministry of Law and Justice or any Central Government or a State Government Press or any other Press or a Newspaper office.
- (iii) Should qualify in a departmental test in English Proof Reading.

**Desirable:-** A degree in Law of recognised University.

**Note 1:** The department officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

**Note 2:** Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of application.

**Note 3:** For the purpose of computing minimum qualifying service of deputation, the service rendered on a regular basis by an officer prior to the 1<sup>st</sup> January, 2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended, shall be deemed to be service rendered in the corresponding pay or pay scale extended based on the recommendations of the said Pay Commission.

3. The pay and other term and conditions of the official selected will be governed by the instructions/orders of the Government of India, on the subject and as amended from time to time.

4. The applications of the interested and eligible officials, whose services can be spared immediately on selection, may please be forwarded in the prescribed proforma (Annexure-I), to Shri B.M. Sharma, Deputy Secretary (Admn.), Legislative Department, Room No. 411, A-Wing, ShastriBhawan. New Delhi alongwithattested photocopies of ACRs of last five years, Integrity Certificate, vigilance clearance and statement showing major/minor penalties, if any, imposed on the candidate during the last ten years.
