VACANCY CIRCULAR

Subject:- Filling up the post of Librarian Grade III in the Official Languages Wing, Legislative Department by absorption/deputation method.

A vacancy in the grade of Librarian Grade III in the Official Languages Wing, Legislative Department, Ministry of Law & Justice is required to be filled by deputation/absorption method.

2. The post of Librarian Grade III in the official Languages Wing is classified as General Central Service, Group 'C', Non-Gazetted, Non-Ministerial and carries the pay scale of Rs.5200-20200/- with Grade Pay of Rs.2000/- .

3. The following is the eligibility criteria for being considered for the said post on deputation/absorption basis: -

Lower Division Clerk working in any office of the Central Government possessing the qualifications prescribed below and having experience of working in a Government Library for a period of three years.

Essential:-

(i) 12th class from a recognised Board or University;

(ii) Certificate in library Science or Librarianship from a recognised Institution; and (iii) working knowledge of Hindi.

Note 1: Qualifications are relaxable at the discretion of the Staff Selection Commission in the case of candidates otherwise well qualified.

Note 2: The qualification regarding experience is relaxable at the discretion of the Staff Selection Commission in case of candidates belonging to the Scheduled Castes or the Scheduled Tribes, if at any stage of selection, the Staff Selection Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

Desirable:-

(i) Working knowledge of colon classification system;

(ii) Ability to type at a speed of 30 words per minute in Hindi or 35 words per minute in English on computer only.

Note 1: The period of deputation including the period of deputation in another ex-cadre posts, held immediately preceding this appointment in the same or some other organisation or Department of the Central Government, shall ordinarily not exceed three years.

Note 2: The minimum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications.

Note 3: For the purpose of appointment on deputation/absorption basis, the service rendered on a regular basis by an officer prior to 1st January,2006 or the date from which the revised pay structure based on the recommendation of the Sixth Central Pay Commission has been extended, shall be deemed to be the services rendered in the

corresponding grade pay or pay scale extended based on the recommendation of the said Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post (s), for which that grade pay or pay scale is the normal replacement grade without any upgradation.

4. Applications are invited from suitable officials in the prescribed proforma (Annexure-I) who are eligible and whose services can be spared. Applications of such officials alongwith their Vigilance clearance, Cadre clearance statement of major/minor penalties and up-to-date C.R. Dossiers of the last five years may be forwarded to the undersigned within 60 days from the date of publication of the Vacancy Circular in the Employment News. Applications received after that date and /or without up-to-date C.R. Dossiers will not be considered.
