- (i) A Degree of a recognized University incorporated by or under a Central Act: Provincial Act or a State Act or any institution for higher education deemed to be a University by the Central Government or any other institution or foreign University approved by the Central Government.
- (ii) Minimum five years experience of Printing work in English in the Ministry of Law and Justice and /or any Central Government or a State Government Press or any other Press or a Newspaper office.
- (iii) Should qualify in a departmental test in English Proof Reading.

Desirable:

A degree in Law of a recognized University.

- **Note 1**: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- **Note 2**: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.
- **Note 3**: For the purpose of computing minimum qualifying service of deputation, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding pay or pay scale extended based on the recommendations of the said Pay Commission.

- 3. The pay and other terms and conditions of the official selected will be governed by the instructions/orders of the Government of India, on the subject and as amended from time to time.
- 4.
