Subject: - Terms and conditions for engagement as Young Professional on contract basis.

The appointment as Young Professional on contract basis in the Legislative Department shall be governed by the following terms and conditions: -

1. The appointment is purely temporary on contract basis for a period of 01 year which would be extendable as per the requirement of the Department. The contract can be terminated without notice by the Competent Authority, if at any time the conduct/performance/activities of the appointee are found detrimental to the interest of the Department.
2. The appointee shall be paid a consolidated amount of Rs. 60,000/- (Rupees Sixty thousand only) per month.
3. The appointee shall perform the duties assigned to him/her by the competent authority from time to time.
4. The appointee shall not be entitled to the benefits like Provident Fund, Pension, Gratuity, Seniority, Promotion etc. or any other benefits available to the government servant who have been appointed on regular basis.
5. The appointee shall not have any claim or right for appointment to any post under the Government on the basis of his/her experience as Young Professional.
6. The appointee shall be required to maintain decorum and office discipline.
7. The appointee shall not undertake any other assignments, paid or otherwise, during the period of contract.
8. The appointee, in addition to the normal working days, in case of exigency of work may be required to attend the office on Saturday/Sunday and other holidays also for which he/she shall not be paid any honorarium/remuneration.
9. The appointee will also be required to take an oath of allegiance to the Constitution of India and make a solemn affirmation to that effect in the prescribed Performa.
10. The appointee is entitled for 08 casual leaves and 02 Restricted Holidays in a year.
11. In case the appointee remains absent without the approval of the competent authority, a proportionate deduction from the consolidated amount of Rs.60,000/- (Rupees Sixty thousand only) may be made. Further, the engagement is also likely to be terminated.
12. If any declaration or information furnished by the person to be appointed as Young Professional turns out to be false or if he/she is found to have wilfully suppressed any material information, he/she shall be liable to be terminated.
13. In case of resigning from the Department, the appointee will have to provide a one month notice to the Legislative Department, failing which No Experience Certificate will be provided to him/her.
14. In case of any circumstances/unforeseen event/dispute etc. not mentioned above, the decision of the Legislative Department will be treated as final.
