VACANCY CIRCULAR

Subject: Filling up of 1(one) vacancy of Assistant (Legal) in the Legislative Department, Ministry of Law & Justice on Deputation/Absorption basis.

It is proposed to fill up one vacancy of Assistant (Legal) in the Legislative Department, Ministry of Law & Justice in Level 7 (Rs.44900-142400/-) in Pay Matrix on Deputation/Absorption basis. The post belongs to General Central Service, Group "B" (Non-Gazetted, Non-Ministerial).

- 2. The eligibility criteria for the posts are as under :-
 - Officials of the Central Government or State Governments or Union Territories:-
 - (A)(i) holding analogous posts on a regular basis in parent cadre or Department; or
 - (ii) with five years' regular service in post in Level 6 (Rs.35400-112400/-) in the Pay Matrix or equivalent in the parent cadre or Department; and
 - (B) Possessing following educational qualifications and experience prescribed:-
 - (i) Bachelor's Degree in Law of a recognised University established or incorporated by or under a Central Act or Provincial Act, or a State Act, or any institution for higher education deemed to be a University by the Central Government or any other institution or foreign University approved by the Central Government; and
 - (ii) Two year experience in legal matters in Central or State Government or Public Sector Undertakings or listed Private Sector Organisations.
 - Note 1: The Officials of the Central and State Governments shall only be considered for absorption.
 - Note 2: The period of deputation (Including Short Term Contract) including the period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not to exceed 3 (three years). The maximum age limit for appointment by deputation shall not exceed 56 (fifty six) years as on the closing date of receipt of applications.
- 3. The pay and other terms and conditions of the official selected will be governed by the instructions/orders of the Government of India, on the subject and as amended from time to time.

The application of the interested and eligible officials, whose services can be spared immediately on selection, may please be forwarded in the prescribed proforma (Annexure-I), to Shri Bhoopendra Singh Bisht, Under Secretary (Admn.), Legislative Department, Room No. 412-B, A-Wing, Shastri Bhawan, Dr Rajendra Prasad Road, New Delhi-110001 along with attested photocopies of APARs of last five years, Integrity Certificate, Vigilance Clearance Certificate and Statement showing major/minor penalties, if any, imposed on the candidate during the last ten years. The applications should reach the undersigned within 60 days from the date of publication of the vacancy circular in the Employment News.
- 5. The applications of only such officials will be considered which are routed through proper channel and are accompanied with (i) Bio-data in proforma given in (Annexure-I) (ii) Cadre Clearance Certificate.
