





# The mobile APP facilitates inspection of minerals during transportation by vehicles:

1.TS-eMining Mobile App serves the field officers at District level (Assistant Director's, Assistant Geologist's, Technical Assistant's, Royalty Inspector's) to verify the validity of the transit forms/passes, sand way bills, Brick Transportation etc., issued by the department.

2 .In case of unauthorized mineral transportation detection, the Mobile App facilitates auto calculation of statutory payments based on the quantity, type and variety of mineral the Payment Link is sent through SMS to the owner of the vehicle to pay penalty online.


3 .It provides online payment facility for the penalty imposed due to non-availability of passes or excess quantity that being transported.

4. Owners/ defaulters shall be communicated through SMS and avoid manual handling of cash by the officers in the field.

5. Online Receipts and Reports shall be viewed and verified by the concerned authorities.





#### Structure of the storage system:

- •Depots are located in different districts.
- •Each depot is divided into godowns.
- •Godowns are further divided into compartments.
- •Each compartment is further divided into stacks.

#### **Classification of stacks:**

- •Stacks contain different commodities.
- •Stacks are classified based on the season and commodities they hold.

#### **Dispatch process:**

- •Dispatch refers to any item or commodity going out from the depot •Commodity dispatches occur from the depot to the MLS (Mandal level Stock) Point.
- •The dispatches follow the FIFO (First-In, First-Out) order, meaning the oldest commodities are dispatched first.

#### **Receipt process:**

Receipt refers to any item or commodity coming into the depot.
Receipts of commodities are received from mills and sent to the depot.
