

## NIC Telangana: Report on the launch of the Bhu Bharati portal on 14th April 2025 (App URL: https://bhubharati.telangana.gov.in)

In commemoration of **Dr. B. R. Ambedkar, 135th birth anniversary**, the Honourable Chief Minister of Telangana, **Shri. A. Revanth Reddy**, formally inaugurated the Bhu Bharati portal at Shilpa Kala Vedika, Shilparamam, Hyderabad, at 5:00 pm in the presence of the Revenue Minister, Deputy CM, and other Ministers & MLAs. The launch was organized by the Department of Revenue and CCLA.

The event was attended by Sh. Guntuku Prasad SIO NIC Telangana, Sh. Radha Krishna ASIO (state), Sh. S. Krishna, Sr. Director (IT) & HoD, ILRMS, along with the team & senior officers Sh. In alignment with its commitment to improving land management, the Government of Telangana has introduced the new **Record of Rights** (RoR) Act, known as the **Bhu Bharati Act, 2025**. This legislation aims to fortify the land records framework and effectively tackle various land-related challenges encountered by citizens. Among its key features, the act introduces an appeal module and modifications to the delegation of processes, which collectively empower local authorities to resolve a greater spectrum of issues at the district level, ultimately serving to benefit the public welfare.

The portal has been meticulously developed and is consistently maintained by the **NIC Telangana**, thereby replacing the previous agricultural land registration system (Dharani portal). The NIC Telangana has been instrumental and has made concerted efforts in the development of the Bhu Bharati portal, incorporating innovative functionalities such as the appeal module and refining existing features to ensure alignment with the provisions of the Bhu Bharati Act, 2025.





This transformative platform epitomizes a comprehensive system for managing land records, designed to significantly enhance the efficiency and accessibility of land-related services.

To facilitate its effective implementation, a pilot program for the Bhu Bharati portal will be initially launched in three designated mandals. After this initial phase, the portal is scheduled to be made accessible throughout all districts of Telangana beginning on June 2, 2025, marking a significant progression in the state's land management and governance practices.
