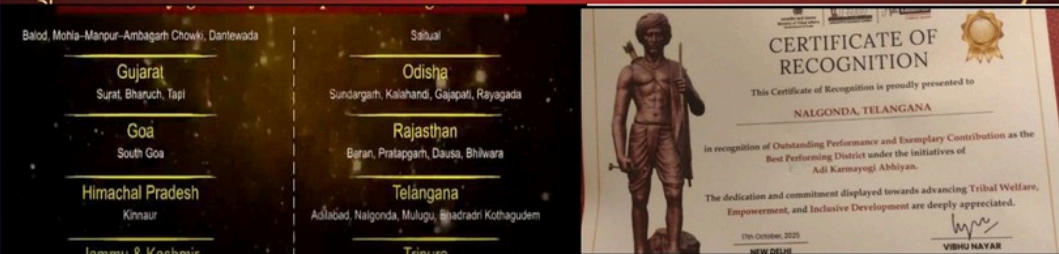

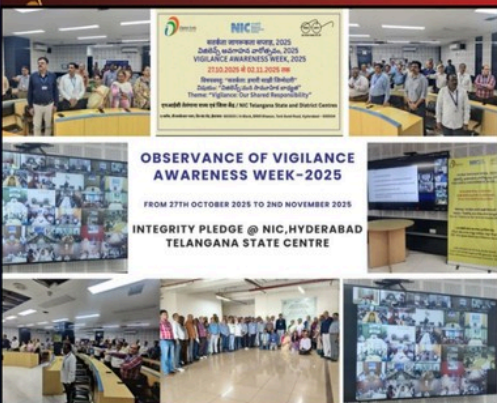

### Cybersecurity Awareness Workshop held on 28th October, 2025 at Chennai



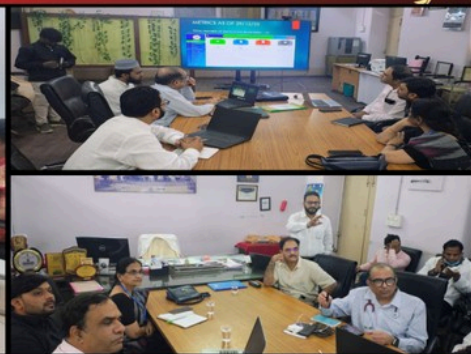

## Tech Insights

### The Invisible Trail: Understanding the Digital Footprint

A **digital footprint** constitutes the trail of data you leave behind when utilizing the internet. It encompasses all your online activities, interactions, and information, whether intentional or inadvertent. Your digital footprint can reveal substantial insights regarding your habits, preferences, and impression of your identity, thus underscoring the importance of understanding and managing it effectively.

#### Types of Digital Footprints:

**Active Digital Footprint** is information you intentionally share online. Posting on social media, completing online forms (e.g., surveys or registrations), sending emails or messages.

**Passive Digital Footprint** is information collected about you without your explicit awareness. Websites tracking your browsing behavior, IP address, location via cookies, location data shared by applications, search engine queries.

#### Components of a Digital Footprint:

**Social Media Activity:** Posts, comments, likes, and shares on platforms such as Instagram, Facebook, or LinkedIn.

**Browsing History:** The websites visited and searches performed.

**Online Purchases:** E-commerce transactions and reviews.

**App Usage:** Data collected by applications, including preferences and habits.

**Emails and Chats:** Content shared through digital communication.

#### Why Digital Footprint Matters:

**Privacy and Security:** Personal data can be exploited for identity theft or fraud, phishing or account hacking; therefore, safeguarding sensitive information online is paramount.

**Reputation Management:** Employers, educational institutions, or business partners may evaluate your online activity; an unmanaged digital footprint could adversely affect your personal or professional reputation.

**Targeted Advertising:** Advertisers/Companies utilize digital footprints to build a consumer profile and deliver targeted advertisements.

**Legal and Compliance Risks:** Certain online actions may contravene privacy laws or organizational policies.

#### Management and Protection Strategies:

**Be Mindful of sharing:** Consider carefully before posting or sharing Personally Identifiable Information (PII) online.

**Tighten privacy settings:** Regularly review and modify privacy configurations on social media platforms and applications and email accounts to limit who can see your information.

**Use robust passwords:** Secure accounts with unique and complex passwords and enable Multi-Factor Authentication (MFA) whenever possible.

**Delete obsolete accounts:** Remove accounts no longer in use to reduce data exposure and data breaches.

**Monitor your online presence:** Periodically search for your name to assess publicly accessible information.

**Ensure secure connections:** Avoid using public Wi-Fi for sensitive transactions; utilize VPNs for enhanced security.

**Opt out of data tracking:** Reject non-essential cookies and restrict application permissions.
