Justice Anu Sivaraman, Judge, High Court of Karnataka and Executive Chairman, KSLSA and Hon'ble Shri Justice R Devdas, Judge, High Court of Karnataka and Chairman, HCLSC, to inform that the HCLSC, all the DLSAs, TLSCs and PLAs in the State to hold second National Lok Adalat on **11.07.2026**.

The following types of cases (pre-litigation and pending) may be taken up for settlement in the second National Lok Adalat:

Pre-litigation

1. Cases under Sec 138 of NI Act;
2. Money Recovery cases;
3. Labour disputes ;
4. Electricity and Water Bills (excluding non-compoundable)
5. Maintenance Cases
6. Others (Criminal Compoundable, Matrimonial and other Civil disputes)
