No. J. 11013/1/2011-LJE: In supercession of this Department's Notification No. J. 11013/1/2011-LJE dt. 4.12.2014 and in exercise of the power conferred under Section 29-A of the Legal Services Authorities Act, 1987 (39 of 1987), the Mizoram State Legal Services Authority is pleased to make the following Regulations to amend the Mizoram State Legal Services Authority Regulations, 2013 (hereinafter referred to 35 the Principal Regulations), namely:

- 1. Short title and commencement
- (1) These regulations may be called the Mizoram State Legal Services Authority (Amendment) Regulations, 2017.
- (2) They shall come into force from the date of their publication in the Mizoram Gazette.
- 2. Amendment of Schedule

For schedule of the Principal Regulations, the following shall be substituted, namely:-

## (A) In all cases before the District Courts, the honorarium shall be as follows:

- For appearance Rs. 750/- per effective hearing and Rs. 500/- for non-effective hearing subject to a
   maximum of Rs. 7,500/- (per case).
- 2. For drafting -
  - (i) Drafting of substantive pleading such as Suit, Matrimonial Proceedings such as Divorce, Maintenance, Custody, Restitution etc., Succession, Probate, Memo of Appeal, Revision, Written Statement, Reply, Rejoinder, Replication etc. Rs. 1,200/-
  - (ii) Drafting of Miscellaneous applications such as stay, bail, direction, exemption etc. Rs. 400/- per application subject to maximum of Rs. 800/- for all applications.

In addition to the above appearance and drafting fees, the following fee will be payable on disposal -

## In all cases before the High Court, the honorarium shall be as follows: (B)

1. For appearance -Rs. 1,000/- per effective hearing and Rs. 750/- for non-effective hearing subject to a maximum of Rs. 10,000/- (per case).

2. For drafting -

Drafting of substantive pleading such as Writ Petition, Counter Affidavit, Memo of Appeal, Revision, Reply, Rejoinder, Replication-Rs. 1,500/-. (iii)

Drafting of Miscellaneous applications such as stay, bail, dir ction, exemption etc. - Rs., 500/- per application subject to maximum of (iv) Rs. 1,000/- for all applications.

In addition to the above appearance and drafting fees, the following fee will be payable on disposal -
