Activities carried out by SLSA

1. Sensitisation Programme on Prevention of Crimes Against Women & Children :

Sensitisation Programme on Prevention of Crimes Against Women & Children was conducted at Sports Centre, Chawnpui on 08.05.2025.

The programme was chaired by Mr. RL. Ziding, Tresurer, Chawnpui Branch YMA and he delivered welcome address to all the participants followed by a short devotion by Ms. C. Lalremruati.

The programme was conducted amongst the parents of the students as Muanna Veng is a locality where most of the refugees of Myanmar admitted their children in this institution.

The programme was chaired by Mr. Vanlaldika, Headmaster, Govt. Muanna PS and Mr. Lalhuliana had a devotion to start the programme.

Mr. C. Vanlalpianglawma, Teacher, UPS delivered a short speech, Ms. Mimi H. Rosiamliani, Project Coordinator, Mizoram SLSA delivered an introductory speech.

The Resource Person Ms. Lalfamkimi, Advocate gave presentation on several topics such as : Child Protection, Responsibility of parents and guardians, Mental health of children etc. Several question were asked during interactive session.

The programme ended with a vote of thanks from the chairperson

150 persons attended the programme and refreshment was served to all the participants.



5. National Lok Adalat :

The Mizoram State Legal Services Authority (MSLSA), in coordination with the eight (8) District Legal Services Authorities (DLSAs) and the High Court Legal Services Committee (HCLSC), successfully conducted the National Lok Adalat on **10th May 2025 (Saturday)** across the entire State of Mizoram. This initiative, held under the aegis of the National Legal Services Authority (NALSA), is part of a nationwide effort to ensure quick and amicable resolution of disputes, thereby reducing the burden on the courts and promoting access to justice for all sections of society.

The National Lok Adalat commenced uniformly at **10:00 AM** across all Legal Services premises, with a total no. of **23 benches were constituted** to take up various categories of cases for settlement.

The Lok Adalat witnessed enthusiastic participation and support from judicial officers, Advocates, social worker and staff members of the MSLSA, DLSAs and HCLSC, as well as Nationalized and Regional Banks and Organizations and most importantly, the general public. Concerted efforts were made in the days leading up to the Lok Adalat to identify suitable cases for resolution, facilitate consent from parties, and prepare comprehensive case lists.

A total of **2,046 cases** were taken up during the National Lok Adalat. Of these, **384 cases were successfully disposed of**, reflecting the commitment and efficiency of all stakeholders involved. The total **settlement amount reached ₹5,39,01,843.43**, which includes monetary settlements in both pre-litigation and pending trial cases.

Among the various categories of cases taken up, **bank recovery matters** constituted the highest share, with **1,105 cases taken up** and **173 cases disposed of**, resulting in a significant settlement amount of **₹2.26 crore approximately**. **Other civil matters**, including family disputes, service-related cases, and miscellaneous civil disputes, also saw substantial resolution, with **432 cases taken up** and **137 disposed**, resulting in a settlement amount of nearly **₹1.90 crore**.

Labour disputes and a limited number of **compoundable criminal cases** were also resolved, reflecting the diverse range of disputes addressed through this forum. The success of this Lok Adalat is a testament to the collaborative spirit between the judiciary, legal services institutions, and the public.

The Mizoram State Legal Services Authority remains committed to the mission of "Access to Justice for All" and will continue to organize such initiatives in the future with greater outreach and impact.



Aizawl DLSA

1. National Lok Adalat :

A total of 79 cases were taken up for consideration, out of which 41 cases were disposed and 37 cases were settled amicably. The cases included mainly money suit and family disputes. The settlement of cases has brought a relief to the parties involved and has helped reduce the burden on the courts.



2. Awareness Programme:

The Programme started with the Inaugural address by Chairperson Mr PC Lalnunhlma, Convener Tleirawl Chawhnu Inkhawm and handed over the programme to the Resource Person.

The session was delivered by Resource Person Ms Lalthanmawii, Advocate on the topic of POCSO Act ,Criminal law and ND&PS Act and followed by interaction session. The programme ended with vote of thanks to all participants from Miss Lalmuankimi, LDC, Aizawl District Legal Services Authority.



3. Jail Visit :

The Programme started with the Inaugural address by Chairperson Ms Lalhriatpuii, Secretary ADLSA, by sharing the importance of humanity. Although, prisoners commit criminal activities ,it is important to let them know that every individual deserves to be treated with dignity and respect, regardless of their circumstances and to help them regain their consciousness for a positive impact on their rehabilitation and reintegration into society.

The session was delivered by Jail Visiting Lawyers and followed by interaction session.



Lunglei DLSA

1. NATIONAL LOK ADALAT :

The DLSA, Lunglei constituted a National Lok Adalat on 10.5.2025 with 2 benches. During the sitting, 230 cases were taken up, out of which 159 cases were successfully disposed of /settled and the settlement amount is Rs. 85,39,746/-.



Kolasib DLSA

1. National Lok Adalat :

On the date of 14th May 2025 (2nd Saturday), National Lok Adalat was held at District Court Kolasib, with two benches organized by District Legal Services Authority, Kolasib. The First bench was conducted under the chairmanship of Mr. R. Vanlalena, MJS, Judge Fastract court, cum AD&SJ, Kolasib. Along with 2 nos. of Conciliators. In the mean time bench no 2 was also conducted which include Mr. Zonunmawia, MJS, JMFC, accompanied by 2 nos. of

Conciliators. On this day, most of the cases were Bank related matters, i.e 70 nos. of cases were taken up and 9 nos. of cases were settled and disposed off. All of the settled amount was **Rs.75,5569 /- (Rupees Seventy Five Lakhs Fifty Five Thousand and Sixty Nine Only)**

Besides of the Bank related cases, other civil cases such as Money Suit- 13 nos. Criminal Compoundable cases- 4 nos. also taken up on this day. All of the settled amount from Civil Cases was **Rs. 59,1450/- (Rupees Fifty Nine Lakhs One thousand four hundred and fifty Only).**



Mamit DLSA

1. National Lok Adalat :

On 10th May, 2025, the Mamit District Legal Services Authority Organized National Lok Adalat on 10.05.2025 at District Court, Mamit.

On this day, National Lok Adalat was constituted with one Bench. A total number of 46 cases were taken up before Lok Adalat in which 46 cases were Pre-Litigation. Out of the total 46 cases, 17 cases were successfully disposed from Pre-Litigation. Hence, 17 cases with the settlement amount of Rs. 8,63,040/- were disposed.



2. Distributing various Leaflets and Booklets :

The Mamit District Legal Services Authority conducted outreach Programme by Distributing various Leaflets and Booklets at Zawlnuam Village and Phuldungsei Village on 26/05/2025 and 27/5/2025 respectively, About 2000 People benefited the Programme.



Serchhip DLSA

1. National Lok Adalat :

The National Lok Adalat was held on 10th May, 2025 at District Court, Serchhip. 56 cases were taken up and 19 cases were disposed. The following table contains the detail report on the cases taken up and disposed off.

2. CONSIDERATION OF APPLICATION UNDER THE MIZORAM VICTIMS OF CRIME COMPENSATION (AMENDMENT) SCHEME :

The Chairman Shri. Helen Dawngliani, District & Session Judge explained the intentions and purview of the Scheme. She then asked Ms. Josangzeli Tlau, Secretary, District Legal Services Authority, Serchhip to give report on the applications, status of the case. Among the 21 applications; 18 applications were due to victim of sexual harassment and rape, the other 3 are due to homicide victim.

The meeting was conducted with Superintendent of Police, Serchhip, Chief Judicial Magistrate, Serchhip and other members of NGO,s.

After all the applications were scrutinized carefully, the following resolutions were made:

- i) In respect of application No.1 of 2023, the applicant Pu Lalhminganga, R/o Hualtu was awarded a sum of Rs.75, 000/- (Seventy Five Thousand).
- ii) In respect of application No.2 of 2024, the applicant Pu Kennedy Malsawmtluanga (ZOAR Home), R/o Serchhip was awarded Rs.4,50,000/- (Four lakhs fifty thousand) only.
- iii) In respect of application No.3 of 2024, the applicant Pi Lallawmsangi, Bazar Veng, Thenzawl was awarded Rs.4,50,000/- (Four lakhs fifty thousand) only.
- iv) In respect of application No.6 of 2024, the applicant Pi Lalnunvuli, R/o Bazar Veng, Bungtlang was awarded Rs.4,50,000/- (Four lakhs fifty thousand) only.
- v) In respect of application No.7 of 2024, the applicant Pi Pawdingliani, R/o Bazar Veng, Bungtlang was awarded Rs.4,50,000/- (Four lakhs fifty thousand) only.
- vi) In respect of application No.8 of 2024, the applicant Pi Laltanpuui, R/o Bazar Veng, Bungtlang was awarded Rs.4,50,000/- (Four lakhs fifty thousand) only.
- vii) In respect of application No.14 of 2024, the applicant Pi Lalbiaknii, R/o Dinthar Veng, Khawlailung was awarded Rs.4,50,000/- (Four lakhs fifty thousand) only.
- viii) In respect of application No.2 of 2023, the applicant Pu PC Lalhlutawma, R/o Dinthar Veng, Serchhip was awarded Rs.2,00,000/- (Two lakhs) only.
- ix) In respect of application No.1 of 2024, the applicant Pu Lalfakawma, R/o Kawn Veng, Keitum was awarded Rs.75,000/- (Seventy five thousand) only.
- x) In respect of application No.9 of 2024, the applicant Pi Lalmuanpuui, was awarded Rs.6,00,000/- (Six Lakhs) only.
- xi) In respect of application No.15 of 2024, the applicant Pi Kaptluangi, R/o Kawn Veng, Keitum was awarded Rs.5,00,000/- (Five lakhs) only.

The next meeting shall be held at the earliest at per exigency.

Champhai DLSA

1. National Lok Adalat :

Lok Adalat was held on 10th May, 2025 two Benches were constituted with two Conciliators on each two benches and two Judicial Officers. 22 cases were taken up and 13 cases were settled. 10 Bank recovery cases and 13 others civil cases were settled. Settlement amount is Rs. 43,79,912.



Lawngtlai DLSA

1. National Lok Adalat :

A National Lok Adalat sitting was conducted at the District Court, Electric veng Lawngtlai. Mr. C. Lalremsanga, JMFC, Ms. Zirthantluangi, Advocate and Laldinpuii, Social Worker attended the sitting. A total of 26 cases were presented, covering civil, family, land disputes and bank cases. Of these, 10 cases were successfully settled, with a total Settlement amount of Rs. 996,783.48/-. The event was a success, providing accessible and quick justice to the community. The involvement of legal and social experts helped resolve disputes fairly, and the event promoted greater trust in the legal system.



2. Jail Visit/Legal Aid Clinic at District Jail, Lawngtlai on 30th May, 2025 :

This Authority conducted Jail visit on 30th May, 2025. At the time of visit, there are 15 nos. of UTPs and 23 nos. of convicts. The visiting Officer Mr. C. Lalrinfela, Deputy Chief LADCS conducted interaction with the under trial prisoners and discuss the matters relating to rights of the UTPs with the inmates. After interaction, the inmates posed many questions and were answered by the visiting Person.
