## **Activities carried out by SLSA**

### **1. SENSITISATION ON SCHEMES OF LEGAL SERVICES INSTITUTION PERTAINING TO WOMEN**

Sensitisation on Schemes of Legal Services Institution Pertaining to Women was conducted at Vanapa Hall, Aizawl 23.04.2025 in collaboration with General HeadQuarter of Mizo Hmeichhe Insuihkhawm Pawl (MHIP) one of the biggest Non- Government Organisations of Mizoram.

The programme was chaired by Mrs. Ngurmawii Sailo, Presdent, MHIP Gen.HQRS and welcomed all the attendees who gathered for the programme. Mrs. Lalzamliani, President, Mamit Sub-HQRS had a short devotion followed by a keynote address delivered by Mr. Vincent Lalrokima, MJS, Member Secretary, Mizoram SLSA.

In the technical session Ms. Lalfamkimi, Advocate gave an insightful presentation on the topic of Women's Rights, Domestic Violence, Sexual Assault and The Mizo Marriage, Divorce & Inheritance of Property Act.

In the interactive session several question were asked by the participants, the Member Secretary and Resource Person cleared their doubts and queries.

The programme was attended by 5 members each from all Districts of Mizoram and a total 1000 members participate in the programme.



## **Aizawl DLSA**

### **1. Victim of Crime Compensation:**

Aizawl District Legal Services Authority distributed compensation to 14 victims at District Judge Room under the chaired by District & Sessions Judge cum Chairman ADLSA. BAR Association members were present at the function. The Chairman said that it is painful that such a time is being spent due to crime and it is a government crime against such individuals. The government wants to us to use this compensation carefully, so that individuals and families can survive.

### **1. Jail Visit/Legal Aid Clinic at District Jail, Lawngtlai on 30<sup>th</sup> April, 2025.**

This Authority conducted Jail visit on 30<sup>th</sup> April, 2025. At the time of visit, there are 13 nos. of UTPs and 20 nos. of convicts. The visiting Officer Mr. C. Lalrinfela, Deputy Chief LADCS conducted interaction with the under trial prisoners and discuss the matters relating to rights of the UTPs with the inmates. After interaction, the inmates posed many questions and were answered by the visiting Person.
