Activities carried out by SLSA

1. Report on Launching of SOP & Flow Chart for dealing cases under ND&PS Act & Training of Trainers

The Mizoram State Legal Services Authority organized launching programme of Bi-lingual Standard Operating Procedure and Flowchart under the ND&PS Act, 1985 and Training of Trainers on 03.07.2025 at Aijal Clu b.

The Programme was graced by his Lordship Hon'ble Mr. Justice Michael Zothankhuma, Judge, Gauhati High Court & Executive Chairman, Mizoram State Legal Services Authority, Hon'ble Mr. Justice Nelson Sailo, Judge Gauhati High Court & Chairman, High Court Legal Services Committee and Hon'ble Mrs. Justice Marli Vankung.

The programme was started with a welcome address from Mr. Vincent Lalrokima, MJS, Member Secretary, Mizoram State Legal Services Authority who mentioned the importance of the launching of SOP and Flowchart of ND&PS Act, 1985.

After which Mr. Lalngaihawma Zote, MJS, Addl. District & Session Judge explained and gave a brief highlights of SOP and its significance. He also mentioned that the police and excise personnel should strictly follow the rules and regulations as per mentioned in the SOP during seizure and arresting of drugs and other psychotropic substances.

Hon'ble Mrs. Justice Marli Vankung also gave a brief comment on the many cases with regards to ND&PS Act in Mizoram. She mentioned that the large amount of cases in Mizoram is largely due to greed for money.

Hon'ble Mr. Justice Nelson Sailo gave a keynote address mentioning that it is very important to follow the SOP of the ND&PS Act so that the perpetrators can be dealt with according to the law and are duly punished.

The Chief Guest Hon'ble Mr. Justice Michael Zothakhuma emphasized on the huge amount of drugs and other substances inside Mizoram. His main concern is that if we continue in our current situation the future for Mizoram is very dark. He also gave congratulation towards the members of the Sub- Committee for ND&PS under Mizoram in their immense effort and contribution in compiling the Bi-Lingual i.e English and Mizo SOP and Flowchart.

After which Mr. Lalrinpuia, SP, Narcotics and Mr. Peter Zohmingthanga, Joint Commisssioner, Excise & Narcotics and Mr. HT Lalmawizual, Civil Judge- Cum JMFC gave detailed training towards the SOP and its contents.

The programme was attended by members of the Mizoram Judicial Services, Mizoram Bar Association, Police Department, Excise & Narcotics Department and Customs Department.

After the training session an interactive session was held and many quires were raised and answered and clarified.

5. Inauguration of Legal Aid Clinics

Locations: Bualpui 'H', Thingsai, Cherhlun, Thiltlang (Lunglei District) and North Vanlaiphai (Serchhip District)

As part of the ongoing initiative of the Mizoram State Legal Services Authority (MSLSA) to promote access to justice for all, a total of six Legal Aid Clinics (LACs) were inaugurated across Lunglei and Serchhip districts on 7th and 8th July, 2025.

Participation and Support

A total of **19 officials and staff** from Aizawl — including the **Member Secretary**, supporting staff, and security/pilot team for the Hon'ble Executive Chairman — participated in the visit. The programme was also actively supported by Secretary of Lunglei and Serchhip, staff from Lunglei and Serchhip DLSAs, who coordinated local arrangements and accompanied the team.

District: Lunglei

Legal Aid Clinics were inaugurated at the following villages under Lunglei District:

1. **Bualpui 'H'**
2. **Thingsai**
3. **Thiltlang**

The Clinics at Bualpui 'H', Thingsai, and Cherhlun were formally inaugurated by the **Hon'ble Executive Chairman, MSLSA**, in the presence of:

- **Member Secretary, MSLSA**
- **Secretary, DLSA Lunglei**
- **Staff from MSLSA and DLSA Lunglei**
- **PLVs, village leaders, and members of the public**

The Legal Aid Clinic at **Thiltlang**, which was newly proposed at the initiative of the Hon'ble Executive Chairman, was inaugurated by the **Secretary, DLSA Lunglei**.

Each Clinic was provided with **one table, four chairs, signboard** and **basic stationery items** as part of the initial infrastructure setup. Public interactions and legal awareness sessions were conducted at each location, during which the Hon'ble EC emphasized the vital role of PLVs and Legal Aid Clinics in ensuring access to justice in remote areas.

A follow-up legal awareness programme was held at every village to deepen community engagement and reinforce the purpose of the newly inaugurated Legal Aid Clinic.

North Vanlaiphai (Under Serchhip DLSA)

The Legal Aid Clinic at North Vanlaiphai, under **Serchhip District Legal Services Authority**, was inaugurated by the **Hon'ble Executive Chairman, MSLSA**, in the presence of:

- **Secretary, DLSA Serchhip**
- **Staff of MSLSA and Serchhip DLSA**
- **Village council leaders and community members**

The Hon'ble EC addressed the gathering, encouraged citizens to utilize the services offered by PLVs, and reiterated MSLSA's commitment to community-based legal support.

The inauguration of these Legal Aid Clinics is a significant step toward extending free legal services to rural populations and empowering citizens through legal awareness. These Clinics will serve as vital contact points for the public to access justice and receive assistance from trained Para Legal Volunteers (PLVs). MSLSA/DLSA will continue to monitor and support these Clinics to ensure their effective and sustainable functioning.





6. The Inauguration of Legal Services Clinic under NALSA Veer Parivar Sahayata Yojana, 2025

On 26th July 2025 (Saturda), the Mizoram State Legal Services Authority (MSLSA), under the National Legal Services Authority (NALSA) Veer Parivar Sahayata Yojana, 2025, inaugurated a Legal Services Clinic at the Directorate of Sainik Welfare & Resettlement, Aizawl.

The clinic was virtually inaugurated by Hon'ble Mr. Justice Surya Kant, Judge of the Supreme Court of India and Executive Chairman of NALSA.

During the event, Surg. Lt. Cdr. Lalnuntluanga, Director of Sainik Welfare & Resettlement, conveyed his gratitude and appreciated the establishment of the clinic within the department premises. Mr. Vincent Lalrokima, MJS, Member Secretary of MSLSA, addressed the gathering, explaining the purpose, functions, and operational system of the clinic, as well as the role of Para Legal Volunteers.

Mrs. H. Lalnunmawii, Superintendent of Sainik Welfare & Resettlement, highlighted the difficulties faced by ex-servicemen and their families, emphasizing that the clinic would serve as an important support mechanism for their legal needs.





7. LOK ADALAT

Regular Lok Adalat was held on 18th July, 2025. This Lok Adalat consist 5 Benches with 15 Conciliators. 142 cases consisting 92 pending cases and other 46 new cases, which include 1 Post Litigation were taken up and 49 cases were successfully settled and disposed of. Settlement amount is Rs. 3,83,55,289/-



8. Report on Talkshow

In order to implement Child Friendly Legal Services to Children Scheme, 2025 talkshow was conducted in the office chamber of Member Secretary, Mizoram SLISA on 30.07.2025.

The talkshow was anchored by Ms. Zorinpui Hlondo. Mr. Vincent Lalrokima, Member Secretary, Mizoram SLISA and Mrs. Julie Lalrinzami, Addl. District & Sessions Judge, Aizawl were the panelist.

The talkshow is to broadcast in the local cable network so as to reach a large number of the society as well as to reach every nook and corner of the state of Mizoram regarding preventive aspect for children from sexual harassment and other crimes.



AIZAWL DLSA

1. Special Campaign On Public Education Of Child Friendly Legal Services To Children With Special Reference To Prevention Of Crime Against Children Under POCSO Act Cum Sensitization Of NALSA Schemes.

This campaign was held at Synod Higher Secondary School on the topic of Public Education Of Child Friendly Legal Services To Children With Special Reference To Prevention Of Crime Against Children Under POCSO Act Cum Sensitization Of NALSA Schemes. Mr Lalremchhunga, Vice Principal as Chairperson, officially starts the programme followed by Mrs. Lalhriatpuii, Secretary , DLSA, Aizawl along with John Khiangte & Mr. Isak giving a comprehensive speech on the Protection of Children from Sexual Offences (POCSO) Act and the said NALSA Schemes, highlighting its key provisions, the importance of protecting children's rights, and the need for sensitivity in handling cases under this law. The programme was therefore, end with a successful and helpful interaction.



2. UTRC Meeting:

A meeting on Under Trial Review Committee (UTRC) is convened to review a cases of under-trial prisoners and recommended releases where eligible.

The Committee examines cases of under – trial prisoners, considering factors like the nature of the offence, duration of imprisonment, and progress in the trial. Based on the review , the UTRC makes recommendations for releases, bail, or other actions to facilitate speedy justice.



3. Lok Adalat

In this Lok Adalat , 30 cases were taken up for Lok Adalat & 7 cases were settled. Settlement amount - Rs. 17,20,853. The main aim of Lok Adalat is to settle pending cases and pre & post litigation through amicable solutions.





4. Mobile Lok Adalat cum Mobile Legal Aid Clinic

Mobile Lok Adalat – cum – Mobile Legal Aid Clinic held on the 26th July, 2025 at Saitual. Out of 23 cases received for Lok Adalat , 21 cases were taken up and 13 cases were settled. Settlement amount for this Lok Adalat is Rs.6,31,704/- .This indicates a high success rate for the Lok Adalat in resolving disputes through mutual agreement between parties. Lok Adalats aim to provide speedy and affordable justice, reducing the burden on the judicial system.



5. Legal Awareness on Sensitization of NALSA Schemes

Legal awareness is the understanding of laws and legal systems that govern everyday life. It's about knowing your rights, responsibilities, and how to navigate the legal system to protect yourself and others.

Mr. K. Lalhlimpuia delivers a compelling speech on legal awareness & NALSA schemes, emphasizing the importance of understanding one's rights and responsibilities under the law to empower individuals and promote a just society.



CHAMPHAI DLSA

1. Legal Awareness Campaign

Legal Awareness Campaign was held on 2nd July, 2025. At Pinehill Adventist Academy, New Champhai. On the topic of POCSO Act & Mizo Marriage, Divorce & Inheritance of Property Act, 2014, 60 people attend this Campaign. Resource person was Lalchhuansanga (advocate) supported by three (3) staff members.

4. Lok Adalat

Lok Adalat was held on 19th July, 2025. 2 Benches were constituted with 2 conciliators on each 2 benches and 2 judicial officers. 23 cases were taken up and 21 cases were settled. 41 other civil cases were settled. Expenditure incurred was 45,42,334.



5. Legal Awareness

Legal Awareness Campaign was held on 21st July, 2025. At Electric Veng Kohhran Hall, on the topic Mizo Marriage, Divorce and Inheritance of property Act, 2013, Domestic violence and Child Marriage under Nalsa-ASHA, Eliminating Child marriage, 2025 Scheme, 60 People attend this Campaign. Resource person was Lalchhuansanga (Advocate)supported by three (3) staff members and two (2) Asst.LADC.



6. Legal Awareness

Legal Awareness Campaign was held on 27th July, 2025. At Parish Hall, Champhai on the topic of MLP Act. & ND&PS under NALSA- Drug Awareness and wellness Navigation for a Drug Free India, 60 members attend this Campaign. Resource person was Solomon Hrahse (Asst. LADC) supported by three (3) staff members.



7. Aadhar Registration Camp

Aadhar registration camp under SAATHI Scheme was held on 22nd July, 2025 at Rose Children's Home and 3 children made aadhar under this scheme.



LUNGLEI DLSA

1. **Conducted a comprehensive assessment and relief of Disaster affected family under NALSA Legal Services to Disaster Victims Scheme for the period from 2nd July, 2025 - 3rd July, 2025**

Under the 'Legal Services to Disaster Victims' scheme, the Core Group under the District Legal Services Authority (DLSA), Lunglei, carried out a comprehensive assessment and relief intervention across multiple villages in Hnahthial District, including Hnahthial Town Area, Thiltlang, Pangzawl, Thingsai and Tawipui, Lunglei District. This initiative aimed to provide legal and humanitarian support to families affected by the disaster.

The core team conducted a comprehensive field assessment to verify and document the needs of disaster-affected families and carried out on the basis of household-level evaluation. The field

intervention was conducted on the 2nd, 3rd, and 4th of July, 2025 in collaboration with local authorities and community organizations, including members of the Young Mizo Association (YMA). This joint effort ensured that every affected family was reached and their specific challenges were clearly documented and relief assistance were provided. A total of 17 disaster affected families have been identified and provided relief assistance.

2. Legal Awareness and Special Campaign on Public Education of Child- Friendly Legal Services to Children with reference to Prevention of Crimes Against Children under POCSO Act held among Jubilee Bible School on 1st July,2025.

The programme was conducted among **Jubilee Bible School, Serkawn**, Ramzotlang. Mrs. Lalthansiami Hnamte was the resource person, addressed the alarming rise in child sexual abuse cases and emphasized its penalties of the offences. An interactive session on the Protection of

Children from Sexual Offences (POCSO) Act, 2012 was conducted with the objective of sensitizing participants about child protection laws, reporting mechanisms, and the importance of creating safe environments for children. Participants expressed increased confidence in identifying and responding to cases of child sexual abuse. A total of 60 participants attended the programme, actively engaging in the sessions and contributing to its success.

3. Legal Awareness and Special Campaign on Public Education of Child- Friendly Legal Services to Children with reference to Prevention of Crimes Against Children under POCSO Act held on 3th July,2025.

A comprehensive legal awareness program was conducted at **Venglai Middle School**, covering two significant legislations in India: The Protection of Children from Sexual Offences (POCSO) Act 2012 and the Motor Vehicles (MV) Act amended in 2019. The event aimed to promote encourage responsible behaviour, and empower students to become informed citizens. Mrs. H. Lalruatfeli served as the resource person, delivered an informative session on both acts.

The students were sensitized about various forms of punishable offenses such as sexual assault, harassment and pornography and educate the importance of mandatory reporting and the penalties for negligence. They were encouraged to speak out against abuse and recognize signs of distress among peers, and report such incidents to trusted authorities. The second part of the session emphasized the importance of road safety and traffic regulations. The resource person

explained the updated provisions including enhanced penalties for violations such as speeding, drunk driving, and mobile phone usage while driving, proper documentation, vehicle registration, and digital licenses etc.

4. **Legal Awareness and Special Campaign on Public Education of Child- Friendly Legal Services to Children with reference to Prevention of Crimes Against Children under POCSO Act held on 16th July,2025.**

The programme was successfully conducted at **Bethel Centre, Sazaikawn Lunglei**, a dedicated shelter and rehabilitation space for destitute children. The initiative aimed to educate and empower both children and caregivers with critical knowledge about child rights, protective legal frameworks, and mechanisms for reporting abuse. The event featured distinguished advocates Mr. ZD Lalnunsanga and Mr. Lalramtiamia as resource persons, who delivered insightful presentations on Alternative Dispute Resolution (ADR) and Legal Ethics. Their deliberations emphasized the importance of ADR mechanisms in promoting timely and amicable resolution of disputes, while underscoring the ethical responsibilities that guide legal professionals in upholding justice. A total of 50 BAR members attended the programme.





6. Legal Awareness and Special Campaign on Public Education of Child- Friendly Legal Services to Children with reference to Prevention of Crimes Against Children under POCSO Act held among Eklavya Model Residential School on 18th July,2025.

A comprehensive legal awareness programme focusing on the Protection of Children from Sexual Offences (POCSO) Act was organized at Eklavya Model Residential School, with the objective of equipping students and educators with essential knowledge on child protection laws. Advocate V. Lalrinawmi served as the resource person, delivered an insightful and engaging session that highlighted the significance of child-friendly legal practices, the mechanisms of safe reporting, and the roles of both institutional and community stakeholders in safeguarding children's rights.

More than 300 participants, comprising both students and teachers, engaged actively throughout the programme.

7. Legal Awareness Campaign and Sensitization on NALSA Schemes on DAWN AND JAGRITI among MHIP Venglai Lunglei on.

A legal awareness and sensitization programme was successfully organized among the members of MHIP Venglai, focusing on the implementation and benefits of the National Legal Services Authority (NALSA) schemes specifically DAWN (Disaster Awareness and Women's Needs) and JAGRITI.

The session was graced by Mrs. Vanlalduati, esteemed Public Prosecutor, who served as the resource person. Her presentation covered a wide range of topics critical to social welfare and legal empowerment. She provided insightful guidance on:

- Maintenance claims under family law
- Procurement of divorce certificates and associated procedures
- Drafting of wills and the legal implications therein
- Other contextually relevant laws and provisions aimed at enhancing legal literacy within the community.

The programme fostered meaningful dialogue through interactive sessions, allowing participants to engage directly with the resource person. Attendees raised questions, shared lived experiences, and received clarifications on various legal matters affecting their day-to-day lives. A total of 70 MHIP members participated in the programme.



8. LOK ADALAT

On 30th July 2025, the District Legal Services Authority (DLSA), Lunglei, constituted one bench for the Lok Adalat, during which 49 cases were taken up and 19 cases were successfully disposed and settled resulting in a total settlement amount of ₹82,269,526/-. Of all the Lok Adalat held previously, this session recorded the highest settlement amount to date.



KOLASIB DLSA

1. LOK ADALAT

On the date of 19th July, 2025. Lok Adalat was held at District Court Kolasib, with two benches organized by District Legal Services Authority, Kolasib. The First bench was conducted under the chairmanship of Mr. V.Vanlalhriata, CJM cum Secretary, DLSA Kolasib. Along with 2 nos. of Conciliators. In the mean time bench no 2 was also conducted which included Ms. Cassandra Zosangzuali, MJS, JMFC, accompanied by 2 nos. of Conciliators.

On this day, all the cases taken up are 14 cases, out of this cases (9 nos.) Money cases from pre & pending, and (5 nos.) Complaint cases from pre & pending. All of the settled amount was **Rs.5,59,724 /- (Rupees Five Lakh Fifty Nine Thousand Seven Hundred Twenty Four Only)** from Money suit.



2. LEGAL AWARENESS CAMPAIGN

District Legal Services Authority, Kolasib organized Legal Awareness Campaign at Kualmawi Branch, YMA Bilkhawthlir, Kolasib on Dt.25th July, 2025. The Resource Person Mr. Zonunmawia, MJS,JMFC Kolasib, he gave lecture on the topic of Criminal & Civil Laws. The Programme was started at 8:00 p.m on YMA Hall Kualmawi Branch.On this programme around 55 peoples of Kualmawi YMA members were attended the programme.

The members who attended these programme were all of them are interesting on the topic.The program was followed by lively interaction and the audience of the YMA members were very attentive and asked several questions about the topics. The resource person Lalrosanga Kawlni, Advocate provided an overview of the NDPS Act, highlighting its provisions and implication. Participants engaged in interactive sessions, asking question and clarifying doubts on the Act.



8. Legal Awareness Campaign through Gram Sabha

A Legal awareness campaign programme was conducted at New Serchhip YMA Hall, through the Gram Sabha initiative on 28th July, 2025. The program drew an impressive attendance of approximately 250 community member.

The resource person Avilla Laltanpuui Renthlei, Advocate provided a detailed presentation on Basic rights of children under the Constitution and various child welfare laws, Role of Legal Aid Services in protecting child victims and ensuring rehabilitation

Students and teachers participated in an interactive session where questions regarding the reporting process, safety measures, and school responsibilities were discussed.



LAWNGTLAI DLSA

1. SURVEY FOR NALSA SAATHI SCHEME

On 28th July, 2025 the DLSA team, Lawngtlai had done a survey at Lairam Motherless Home & Oasis boys Home to identify children who had not been enrolled under Aadhaar as part of the ongoing efforts under the NALSA SAATHI Scheme.

At the time of visit 4 children from Lairam Motherless Home and 1 from Oasis Boys Home were identified as not having Aadhar card, the DLSA team immediately took steps in the process of identifying the documentation needed for registration. After that, all the unidentified children for Aadhar registration were safely accompanied and guided to DC Office, PEC (Public Enrollment Center) & Biometric Enrollment Center (BEC) for registration.



2. Awareness Campaign

(A) Electric Veng YLA

An Awareness Campaign was held on 3rd July 2025 at LWA Hall, Electric Veng with the Young Lai Association Electric Veng Branch, the programme was attended by 80 members and was chaired by Pu T. Lalrinfela, Branch Executive Member and welcomed the DLSA Team. The resource person was Pu. C. Lalbiakkima, Assistant Public Prosecutor(APP) and he focuses on the role of Non-Governmental Organizations (NGOs) and Private persons in supporting the enforcement and objectives of the Narcotic Drugs and Psychotropic Substances (NDPS) Act, 1985. The event aimed to educate the civil society about their rights, responsibilities, and opportunities to contribute towards a drug free society.

The Intention of the campaign was to create public awareness about the provisions of the NDPS Act, to highlight the crucial roles that NGOs and Private Citizens can play in drug prevention, rehabilitation, and law enforcement support it is also to build a collaborative framework between the Government, civil society, and the public.

The Awareness Campaign successfully sensitized participants about the importance of collective responsibility about the importance of collective responsibility in the fight against drugs. NGOs and private individuals are not just supporters but active partners in the implementation of the NDPS Act.

The Programmed concluded with a call to action-encouraging attendees to become Advocates for a dug free society by being informed, vigilant and proactive.



(B) MHIP Day

On 5th July, 2025 an awareness programme was conducted on MHIP Day at Lawngtlai-III multipurpose Hall, the programme was attended by members of MHIP from Lawngtlai-III Branch

which is approximately 150 members, the main aim of this awareness was to focus on women related laws , Marriage and Divorce Act and NALSA ASHA Scheme.

The resource person Zirthantluangi, Chief LADC (Legal Aid Defense Counsel) addresses the attendees on the said topics and spoke deliberately on the main objectives of the NALSA ASHA Scheme and further emphasized on laws related to women and child which protects their rights in India, including Marriage and Divorce Act, she also stressed on how this Act envisions the ground for distribution of matrimonial property and addresses the inheritance of property. She also includes legislation related to domestic violence, dowry prohibition, sexual harassment at the workplace, and constitutional provisions guaranteeing equality and dignity for women.

At the end of the programme an interactive session where most of the MHIP Member raises questions on their concern related to the topics, the programme was winded with positive feedbacks from the members.



(C) Central YLA Rorel Inkhawm

Awareness Campaign was held by the District Legal Services Authority (DLSA) on 7th July, 2025 at Chanmari Inpui with the Central Young Lai Association on the topic of *Motor Vehicle Act & NALSA DAWN Scheme*. The Programme was chaired by the CYLA Games & Sports Secretary Pu S. Lalmalsawmsanga and welcomed the DLSA Team. The Programme was attended by 416 members and the resource person was Pu C. Lalremsanga, Judicial Magistrate First Class (JMFC).

The resource person introduced NALSA DAWN Scheme and also talks about the MV act. The Awareness was to educate about the key aspects of Motor Vehicle Act, promote Drugs Abuse prevention and guide each individual towards better wellness practices.

Further he explained the essential provisions of the Motor Vehicle (Amendment) Act, especially the importance of wearing helmets and seat belts and also avoiding over-speeding and drunk driving. The speaker also addresses penalties for traffic rules violations.

The harmful effects of substance abuse were explained with real life case studies and emphasis was laid on the Psychological, social and legal consequences of drug addiction. The resource person highlighted the importance of family, peer support and early intervention.

The Awareness Campaign proved to be a meaningful platform to educate and empower the public/youth on the importance of following road safety rules, staying away from harmful substances, and adopting a healthy lifestyle. It was heartening to witness the active participation and enthusiasm of the attendees. Such initiatives play a crucial role in building a safer, healthier and more responsible society.



(D) TKP Maranatha Unit

A Special Awareness Campaign was organized by the DLSA, Lawngtlai, on 11th July, 2025 at Maranatha Baptist Kohhran Hall with Thalai Kristian Pawl (TKP) & Jr.TKP Maranatha Unit. The programme was chaired by the Treasurer NI. Puipuii and welcomed the DLSA Team. The resource person was Pu C. Lalrinfela, Advocate and 105 were participated in this Programme.

The resource person talks about the child friendly legal services and educate the youth on the prevention of crimes against children with a specific focus in the Protection of Children from Sexual Offences (POCSO) Act, 2012.

The Awareness aimed at sensitizing children, teachers etc. at large about the rights of children, the legal protections available to them and the importance of creating a safe and supportive environment for every child.

The purpose of the campaign was to raise awareness about the POCSO Act and other child protection laws. To promotes child-friendly legal aid mechanisms and access to justice for minors. To educate the youth on recognizing, preventing and reporting crimes against children. To build a community based support system to protect children from abuse and exploitation.

The resource person gave an overview of the POCSO Act, 2012 including the definition of sexual offences; mandatory reporting of abuse (Section 19), special procedures for child victims in courtrooms and also the importance of maintaining confidentiality and sensitivity in dealing with child victims was emphasized.

The information was provided on the availability of legal services for children, Free Legal Assistance through Legal services Authorities, support from Juvenile Justice Boards (JJBs) and Child Welfare Committees (CWCs).

The campaign serves as a crucial step towards strengthening the child protection ecosystem by fostering awareness, accountability and access to child-friendly legal services. It reinforced the idea that every child deserves to grow up in a safe, supportive and empowering environment.



(E) Awareness campaign at Venglai PCD

On the 6th of July, 2025 the District Legal Services Authority (DLSA), Lawngtlai, organized an awareness campaign at Venglai Kohran Hall on the topic of *"Protection of Children from sexual Offences Act POCSO"* and aimed to educate member present on the significance of child protection and the legal provisions available under the POCSO Act, 2012. The campaign was attended by 80 members.

The resource Ms. Jothansangi Tlau, CJM spoke deliberately on the provisions of the POCSO Act, raising awareness on protection of children from sexual assaults and harassment, she also address the system available for victims and improved method for apprehending offenders, she also stated the responsibilities of adults in identifying and reporting such crimes, and the legal recourse available to victims and their families. She also emphasized the importance of open communication between children and their guardians, and she highlighted the role of schools and communities in ensuring that children are protected from harm. Through her talk, she encouraged the audience to be vigilant and proactive in preventing abuse and to utilize legal mechanisms to seek justice when necessary.

The campaign concluded with a renewed sense of awareness among the attendees. Many expressed their appreciation for the valuable insights provided and acknowledged the importance of such initiatives in fostering a safer environment for children.



(F) Awareness campaign on BCM AOC

An awareness programme was conducted at BCM Kanan unit, AOC Lawngtlai on 18th July, 2025. The programme was attended by approximately 70 TKP Members. The main objective of this awareness programme was to focus on NALSA ASHA Scheme and Consumers protection rights.

Mr. Johny Malsawmsanga Secretary TKP Kanan Unit chaired the programme. The resource person Mr. C.Lalremsanga Judicial Magistrate First Class (JMFC) had delivered insightful information on the topic of Consumer Protection Act and further explains how wills are supposed to make according to the Indian Succession Act, 1925. He also stressed on the NALSA ASHA Scheme as how the scheme is designed to combat child marriage and also how legal support and rehabilitation are provided.

The programme was concluded with a successful interactive session, raising interesting questions which helped clarified their doubts and gained knowledge.



(G) UPC Bazar Kohhran

A legal awareness campaign was successfully organized by the District Legal Services Authority (DLSA) Lawngtlai at Bazar Kohhran Hall at 27th July, 2025. The event was attended by around 150 church members, both men and women from various age groups. The main objectives of this campaign was to create awareness about the legal provisions under the Motor Vehicle Act, 2019, road safety norms and to inform citizen about their legal obligations as loan guarantors, the potential financial risks involved and to make legal knowledge accessible and relevant to common people.

The first resource person Mr. T. Chanchinmawia, Prosecution Inspector, Lawngtlai prosecution Branch gave an insightful presentation on the key amendments under the Motor Vehicle Act, 2019 and their implications. He also stressed on the increased penalties for common violation such as over speeding, drunk driving, driving without license, helmet etc, and also introduced the rules on Juvenile driving where guardians or vehicle owners may be held accountable, he emphasized the need for every citizen to be a responsible road user to reduce accidents and fatalities. He emphasized how even minor negligence can lead to serious consequences and encourage everyone to be mindful of road safety.

The second session was led by Mr. Andy Lalengkima Assistant manager, State Bank of India Lawngtlai Branch, who spoke about the often-overlook legal responsibilities and financial consequences of being a loan guarantor. He further explained who is considered a guarantor under Indian law, the fact that a guarantor is equally liable for the repayment of the loan incase the borrower defaults. The legal process through which banks and financial institutions can recover money from guarantors, real life examples of individuals who suffered financial losses due

to unawareness of their duties as guarantors. He also talks about the importance of reading and fully understanding the terms of any loan agreement before signing as a guarantor. He strongly advises the attendees to act with caution and responsibility before agreeing to be a guarantor for anyone, even close friends or relatives.

The sessions were followed by a brief interactive segment where attendees asked practical questions, the speaker answered each questions clearly and patiently, helping participants understand legal matters in simple language.



3. Lok Adalat

A Lok Adalat was successfully conducted on 25th July 2025 at CJM Chamber, District Court Building, Lawngtlai where total of **20 pre-litigation cases and 12 post-litigation cases** were presented before the Lok Adalat. These cases primarily involved civil matters, money recovery, and bank settlements.

Out of the total cases presented, **4 cases were successfully settled** through mutual agreement between the parties involved. The proceedings were conducted in a cordial and cooperative environment, ensuring that justice was delivered in an expeditious and cost-effective manner. The **total settlement amount** achieved during the Lok Adalat stood at **Rs. 5,36,774/- (Five lakh thirty six thousand seven hundred seventy four only)**, marking a significant financial resolution through consensual and non-adversarial means.



4. Jail Visit/Legal Aid Clinic at District Jail, Lawngtlai on 27th June, 2025.

This Authority conducted Jail visit on 30th July, 2025. At the time of visit, there are 6 nos. of UTPs and 21 nos. of convicts. The two visiting Officer Mrs. Zirthantluangi, Chief Legal Aid Defence Counsel and Mrs. Nelly H. Lalrammuani, Deputy Chief LADC, conducted interaction with the under trial prisoners and discuss the matters relating to rights of the UTPs with the inmates. After interaction, the inmates posed many questions and were answered by the visiting Person.

1. Legal Awareness Campaign

The Mamit District Legal Services Authority Organized National Lok Adalat on 17.07.2025 at District Court, Mamit.

On this day, National Lok Adalat was constituted with one Bench. A total number of 28 cases were taken up before Lok Adalat in which 28 cases were Pre-Litigation. Out of the total 28 cases, 11 cases were successfully disposed from Pre-Litigation. Hence, the settlement amount of Rs. 2,00,765/- were disposed.



5. Opening of Legal Aid Clinic

On 24th July 2025, a Legal Aid Clinic was officially inaugurated at Ailawng, Mamit District under the initiative of the District Legal Services Authority, Mamit. The clinic aims to provide free legal assistance and awareness to the residents of Ailawng and nearby areas, especially those who cannot afford legal representation.

The inauguration program was attended by PLV's from District Legal Services Authority, Mamit and Ailawng village, Mamit District. This initiative marks a significant step toward ensuring justice for all and promoting legal literacy in rural areas.



6. Aadhaar Enrollment under SAATHI Scheme

On 24th July 2025, the District Legal Services Authority (DLSA), Mamit organized an Aadhaar enrollment drive for destitute children under the SAATHI Scheme at Reiek, Mamit District.

A total of 8 destitute children were successfully enrolled for Aadhaar during the drive. The program aimed to help children obtain a valid identity document, which is essential for accessing various social security schemes, education, and healthcare services.



7. Opening of Legal Aid Clinic

On 24th July 2025, the District Legal Services Authority (DLSA), Mamit inaugurated a Legal Aid Clinic at Reiek, Mamit District. The clinic is established to provide free legal services and legal awareness to the local community, especially to those who cannot afford legal representation.

The inauguration program was attended by Para Legal Volunteers (PLVs) from DLSA Mamit and PLVs stationed at Reiek. This Legal Aid Clinic is expected to serve as an accessible point for delivering justice at the grassroots level and empowering citizens with knowledge of their legal rights and remedies.



8. Legal Awareness Campaign

On 28th July 2025, the District Legal Services Authority (DLSA), Mamit conducted a Legal Awareness Campaign at DIET, Mamit, focusing on Environmental Protection and various NALSA Schemes in collaboration with SAVE,Mamit. The session aimed to educate the participants about environmental laws, conservation responsibilities, and detailed information was provided on various NALSA Scheme such as JAGRITI,ASHA,DAWN,SAATHI, etc.

The Resource Persons were Shri.H.Lalduhsanga, Chief Judicial Magistrate (CJM), Mamit, and Mr.Robert Zoramliana, President, SAVE, Mamit.



9. Legal Awareness Campaign

On 31st July 2025, the District Legal Services Authority (DLSA), Mamit conducted a Legal Awareness Campaign at Presbyterian English School, Mamit. The programme focused on '*Prevention of Children from Crime under POCSO Act, 2012*' and *Various NALSA Scheme*.

The Resource Person was Shri.H.Lalduhsanga Chief Judicial Magistrate, who provided detailed insight into the POCSO Act,2012, highlighting its role in protecting children from sexual offences. The importance of early reporting, legal procedures, and community vigilance was emphasized.

The session also aimed to educate the participants about the detailed information on various NALSA Scheme such as JAGRITI,ASHA,DAWN,SAATHI, etc.
