2. STREET CAMPAIGN/SOLID WASTE MANAGEMENT AWARENESS/CLEANLINESS DRIVE IN MAMIT TOWN

As part of our Special Campaign, we successfully conducted “Street Campaign/Solid Waste Management Awareness/Cleanliness Drive” on 6th February 2025. We collaborated with the National Service Scheme (NSS), Govt. Mamit College to conduct this initiative and about 100 members participated. In this Clean-up initiative, we collected and properly disposed of various waste materials including Plastic bottles, Polythenes, Glasses and so on.



3. LEGAL AWARENESS CAMPAIGN ON POVERTY ALLEVIATION & ENVIRONMENTAL PROTECTION

Venue: Suarhliap, Mamit District

Date: 10th February, 2025

The 100 Houses Suarhliap village hosted its first-ever legal awareness campaign on the night of 10th February, 2025 at Village Council Hall, Suarhliap. The several leaflets focusing on Environmental Protection were handed out during the event.

- (a) **Success Story:** During interaction session, a woman stood up and shared a heart-touching story. She had been caring for her brother's children who were left behind. When their father was imprisoned and their mother abandoned them. She could not work and unable to provide properly the basic needs as well. The woman humbly asked if we could offer any assistance. We promptly took her phone number and personally informed the District Child Protection Officer (DCPO), Mamit about the situation. Fortunately, an action was taken and arrangements are now being made to accommodate the children in Children's home.
- (b) **Success story:** Another story was that a woman who never knew before about the Mizoram Victims of Crime Compensation Scheme, 2011 stood up and upon learning about the scheme, she shared distressing story of having suffered physical injury and filing an FIR. We clearly explained the scheme's details and assured her that she could approach us to seek compensation. We took her contact number.
- (c) **Success story:** There was one more story that a man stood up and revealed that their land was donated for construction of a Forest Rest House under the condition that one family member would be employed. One building was constructed by them under a contract. However, despite completion of three buildings, the promise remained unfulfilled. He humbly asked if we could offer any legal assistance. We informed him about the availability of free Legal Aid Counsel and the matter shall be informed to the Legal Aid Counsel. We also took his contact number.



4. LEGAL AWARENESS CAMPAIGN

Venue: District Court, Mamit

Date: 14th February, 2025

We conducted Legal Awareness Campaign on NALSA (Child-Friendly Legal Services for Children) Scheme, 2024 & Environmental Protection at District Court on 14th February, 2025 with the District Child Protection Office, Observation Home, Buannel Children's Home and Joshua's Children's Home and all the participants collectively vowed to protect and conserve forests and wildlife.

Success story: It was a successful event because this initiative successfully forged a partnership between the Mamit DLSA, District Child Protection Office and Children's Home paving the way for collaborative efforts in the future.

Laldusanga, CJM, Mamit and attended by several key figures including Smti. Esther Zorini Hauhnar JMFC, Pukhraj Kamal IPS, SP, Mamit and Smt. Grace Lalremdiki Sailo MCS, SDC. Other important bodies were also present. The 29 lakh was distributed to the 7 crime victims.

Venue: Excise & Narcotics Office, Mamit

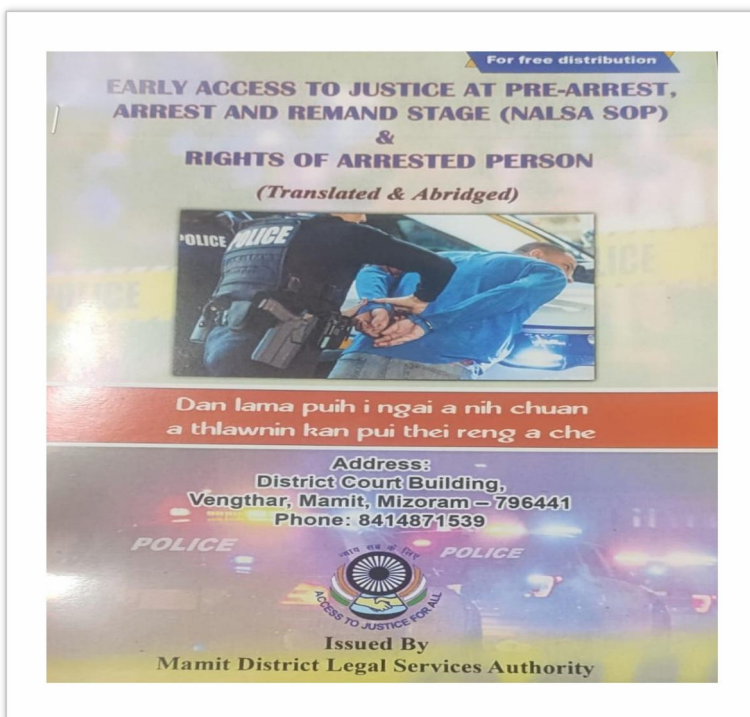
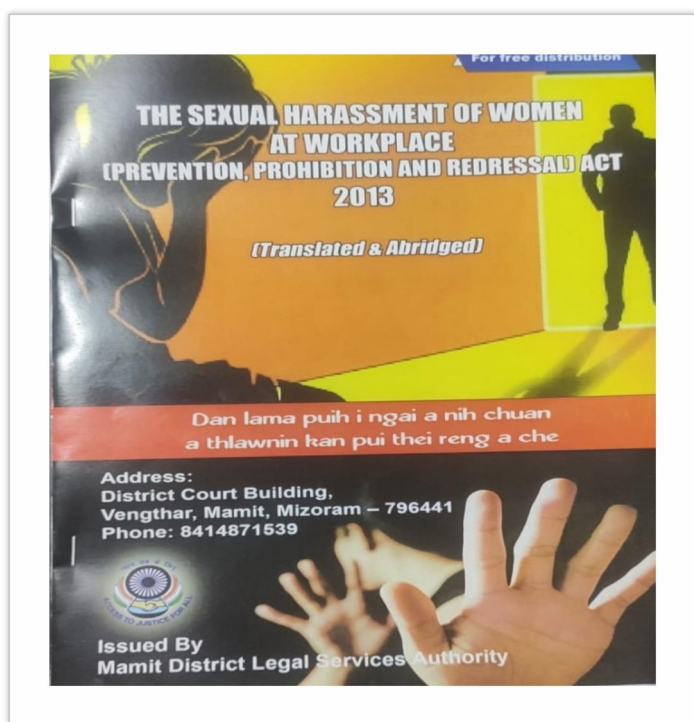
Date: 21st February, 2025

On 21st February, 2025, we organized a Legal Awareness Campaign on three new Criminal Laws and Environmental Protection for the Excise & Narcotics personnel at Excise & Narcotics Department Hall, Mamit. The event began with an introductory speech by Smti. Esther Zorini Hauhnar, JMFC, followed by a detailed session led by Smti. Vanlalfaktluangi, Assistant Public Prosecutor, Mamit District Court. The Excise & Narcotics Department engaged in an interactive discussion with the resource person, addressing questions and concerns they faced regarding the new laws. Additionally, the resource person delivered a speech on environmental protection, further emphasizing the importance of legal awareness and proactive measures for a better society.



8. BOOKLET

We translated in the local language and published four Booklets i.e, NALSA SOP “Early Access to Justice at Pre-Arrest, Arrest and Remand Stage (Abridged), The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (Abridged), The Legal Services Authorities Act, 1987 (Abridged) and the Role and function of Mamit District Legal Services Authority (DLSA). These booklets are intended for free distribution. The cover of each booklet included our Office Address ie, District Court Building, Vengthar, Mamit and Contact Number (8943637383) inviting each individual to contact us at any time in the given number for free legal assistance. The sufficient copies of NALSA SOP “Early Access to Justice at Pre-Arrest, Arrest and Remand Stage have been provided with all the Police stations, Police Outpost and Excise & Narcotics Department in the District with a request to make the persons arrested and brought in the custody for interrogation or interview read in order to aware of their rights before questioning commences. The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (Abridged) would also be distributed to the Government Offices, Homes, Restaurants and Teas Stall. The other two Booklets would be distributed during our Legal Awareness Campaign and Outreach Programme.



9. LEGAL AWARENESS CAMPAIGN

Venue: Dampui, Mamit District

Date: 24th February, 2025

There is a famous ‘Zongaw forest’ in our District closed to a small village called Dampui. Unfortunately, this forest has fallen victim to rampant deforestation driven by personal gain. In response, we launched an Environmental Protection campaign in this small village on 24th February, 2025. A significant milestone was achieved when about 50 young individuals pledged to refrain from cutting down trees in this forest and to preserve it in future.

11. ZERO (0) - EXPENDITURE AWARENESS

Venue: Mamit

Date: 12th February, 2025

We aimed to organize at least one programme without any expenditure. The aim came true on the polling day of Village Council Election held on 12th February, 2025 (Wednesday). It was a standout activity and achieved without incurring any expenses. We collaborated with the Office of Divisional Forest Officer, Mamit Forest Division and obtained from them leaflets/booklets/magazines focusing on Environmental Protection. On the polling day, our distributing team efficiently covered 7 polling booths within Mamit town deploying 13 staff to distribute these 10 different reading materials such as Ram tikang lo turin I fimkur ang u, Forest Khawvel etc. The 4645 voters turned out and we distributed approximately 4,000 leaflets/booklets/magazines around the polling booths. We received excellent support from the Court staff and Legal Aid Counsels in this initiative. It was successful and of course, zero-expense and time-saving initiative.
