1. Adhaar Enrollment under SAATHI Scheme

Venue :West Phaileng, Mamit District

Date :5th August, 2025

On 5th August 2025, the District Legal Services Authority (DLSA), Mamit organized an Aadhaar enrollment drive for destituted children under the SAATHI Scheme at West Phaileng, Mamit District.

A total of 20 destituted children were successfully enrolled for Aadhaar during the drive. The program aimed to help children obtained a valid identity document, which is essential for accessing various social security schemes, education, and healthcare services.





2. Adhaar Enrollment under SAATHI Scheme

Venue :Joshua Children Home and Buannel Home, Mamit

Date :7th August, 2025

On 7th August 2025, the District Legal Services Authority (DLSA), Mamit organized an Aadhaar enrollment drive at Joshua Children Home and Buannel Home, Mamit, as part of the SAATHI Scheme.

During the initiative, 22 destituted children were successfully registered for Aadhaar. This program was designed to provide these children with a valid identity document—an essential step toward enabling access to:

- Educational opportunities
- Healthcare services
- Social welfare schemes

The drive reflects a commitment to ensuring that vulnerable children are not left behind and can benefit from the rights and services available to every citizen.





3. Legal Awareness Campaign

Venue :Hmarveng Community Hall, Mamit

Date :7th August, 2025

A legal awareness campaign was held on 7th August 2025 at Hmarveng Community Hall, Mamit, organized by the District Legal Services Authority, Mamit. The campaign focused on "*Protection of Children from Crime under POCSO Act*,2012" and "*Various NALSA Scheme*"

The Resource Person was Shri.H.Lalduhsanga Chief Judicial Magistrate, who provided detailed insight into the POCSO Act,2012, highlighting its role in protecting children from sexual offences. The importance of early reporting, legal procedures, and community vigilance was emphasized.

The session also aimed to educate the participants about the detailed information on various NALSA Scheme such as JAGRITI, ASHA, DAWN, SAATHI, SAMVAD, etc.





4. Legal Awareness Campaign

Date :18th August, 2025

A Legal Awareness Campaign on "Prevention of Child Marriage under NALSA (ASHA - Awareness, Support, Help and Action) Standard Operating Procedure – Towards Eliminating Child Marriage, 2025" was organized at Chhimveng, Mamit on 18th August 2025.

The programme aimed to sensitize the community on the legal, social, and health implications of child marriage, and to spread awareness of the mechanisms available under NALSA's ASHA SOP for prevention and elimination of the practice.

The Resource Person, **Smt. Esther Zorini Hauhnar, JMFC** Mamit, highlighted the provisions of law prohibiting child marriage, the role of various stakeholders in its prevention, and the importance of community participation in safeguarding the rights of children.





5. Openining of Legal Aid Clinic

Venue :Mamit Police Station ,Mamit District

Date :22nd August, 2025

A Legal Aid Clinic was officially inaugurated at Mamit Police Station on 22nd August 2025 under the initiative of the District Legal Services Authority, Mamit.

The inauguration program was attended by PLV's from District Legal Services Authority, Mamit and Staff of Mamit Police Station. The initiative aims to provide free legal services and assistance to the public, particularly to those in need of immediate legal support. The opening of the clinic marks a step towards strengthening access to justice and ensuring legal aid is available at the grassroots level.



6. Legal Awareness Campaign

Date :22nd August, 2025

On 22nd August 2025, the District Legal Services Authority (DLSA), Mamit conducted a Legal Awareness Campaign at Venghlun, Mamit. The programme focused on *'Prevention of Children from Crime under POCSO Act, 2012'* and *Various NALSA Scheme.*

On this day, National Lok Adalat was constituted with one Bench. A total number of 15 cases were taken up before Lok Adalat in which 15 cases were Pre-Litigation. Out of the total 15 cases, 4 cases were successfully disposed from Pre-Litigation.

A Legal Awareness Campaign on **NALSA's Schemes (ASHA, DAWN, JAGRITI,SAMVAD)** was organized by the Mamit District Legal Services Authority at Luangpawl, Mamit on 25th August 2025.

9. Legal Awareness Campaign
