### 1. Awareness on New Criminal Law

Venue : Sunday school hall, Mizoram UPC, Mamit

Date : 2<sup>nd</sup> September, 2024

On 2<sup>nd</sup> September, 2024, the Mamit District Legal Services Authority organized Legal awareness on New criminal Laws India amongst the Pentecostal Youth Department (PYD) Mizoram UPC, Mamit.

On the day, Mr. Vaninmawia Khawlhring, Legal Aid Counsel, District Court, Mamit being the resource person gave awareness on the legal concepts of three new Criminal laws of india I.e the "**Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita, and Bharatiya Sakshya Adhiniyam**", The Pentecostal Youth Department (PYD) had a great interaction with the resource person regarding the new laws and showed gratitude for the knowledge conceived through the awareness given to them.



### 2. National Lok Adalat

Venue : District Court, Mamit

Date : 14<sup>th</sup> September, 2024

On 14<sup>th</sup> September, 2024, the Mamit District Legal Services Authority organized National Lok Adalat on 14.09.2024 at District Court, Mamit.

On this day, National Lok Adalat was constituted with one Bench. A total number of 64 cases were taken up before Lok Adalat in which 59 cases were Pre-Litigation and 5 cases were Post Litigation. Out of the total 64 cases, 14 cases were successfully disposed from Pre-Litigation and 5 case was disposed from Post Litigation. Hence, 19 cases with the settlement amount of Rs. 7,66,640/- were disposed.



### 3. Awareness Campaign

Venue: District Jail, Mamit  
Date : 19<sup>th</sup> September, 2024

On 19<sup>th</sup> September, 2024, the Mamit District Legal Services Authority conducted Legal Awareness Campaign amongst the inmates of District Jail, Mamit.

The campaign aimed to spread awareness about the three new criminal laws. The resource person, Mr. H. Lallawmkima, Advocate cum Panel Lawyer, DLSA, Mamit spoke on the three new criminal laws namely the "**Bharatiya Nyaya Sanhita, 2023, Bharatiya Nagarik Suraksha Sanhita, 2023 and the Bharatiya Sakshya Adhinyam, 2023**". An interactive session with the prisoners was also held. H. Lallawmkima explained about the free legal assistance to the prisoners.
