## 1. Observation of MHIP Day

Venue : Chhim Veng Hall, Mamit Date : 6<sup>th</sup> July, 2024

On this day, Smt. Esther Zorini Hauhnar, Judicial Magistrate 1<sup>st</sup> Class was a resource person. Around 300 women gathered to listen the lecture given by the resource person on this campaign. Smt. Esther Zorini Hauhnar, JMFC delivered a speech on the topic of **The Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal) Act, 2013** which was followed by interaction in which 7 women asked about their legal doubts and uncertainties.
