1. Observance of International Women's Day on 8th March, 2023
Resource Person – Smt. Renee Lalremsiami, Chief Judicial Magistrate-cum- Secretary, DLSA, Lawngtlai District, Lawngtlai.

This Authority observed International Women's Day on 8th March, 2023 at MJA Hall, Lawngtlai in collaboration with MHIP Sub-Headquarters, Lawngtlai . Smt. Renee Lalremsiami was the Resource Person. The Resource Person gave a speech on the topic 'Women's Rights' and the speech was then followed by an interaction session and many questions were raised by the audience which the Resource person answered to their questions satisfactorily.



2. Disbursement of Victims of Crime Compensation

DLSA, Lawngtlai on 13th and 14th March, 2023 disbursed a total sum of Rs. 10,00,000/- to two claimants who have been awarded Victims of Crime Compensation under the Mizoram Victims of Crime Compensation Scheme, 2011. These two claimants were recommended for compensation under the Scheme of 2011 by the Hon'ble District & Sessions Court, Lunglei, Lunglei Judicial District which were later on approved by DLSA, Lawngtlai and SLSA, Mizoram, Aizawl respectively. The amounts of compensation have been paid by way of banker's cheque to the respective claimants.



3. Jail Visit/Legal Aid Clinic at District Jail, Lawngtlai on 31st March, 2023
Resource Person – Smt. Renee Lalremsiami, Chief Judicial Magistrate – cum- Secretary, DLSA Lawngtlai District, Lawngtlai.

This Authority conducted Jail visit on 31st March, 2023. At the time of visit, there are 15 nos. of UTPs and 11 nos. of convicts. The visiting Officer/Resource Person conducted interaction with the under trial prisoners and discuss the matters relating to rights of the UTP's with the inmates. After interaction, the inmates posed many questions and were answered by the Resource Person.
