I. Awareness Campaign

1) College Veng, Kohhran.

On 2nd October, 2025, an awareness campaign was held at College Veng Kohhran. The programme was attended by 120 church members. The main focus of this programme was to educate the attendees on the Motor Vehicle Act, as well as the NALSA (Ensuring Access to Justice for Widows Living in Shelter Homes) scheme.

The Resource person, Mr. PC Lalchhuanpuia, stressed on the NALSA (Ensuring Access to Justice for Widows Living in Shelter Homes) scheme, by giving information on how the scheme provides free legal services to widows, including help with obtaining identity documents like Aadhaar and voter Id, accessing welfare schemes, and asserting property or inheritance rights.

The Resource person emphasizes the importance of obeying traffic rules and the necessity of registering at the District Transport Office (DTO). He elaborated on various traffic regulations and fines, highlighting the potential penalties associated with violations.

He provides examples of common violations, such as speeding, driving without a valid license, licensing default, underage driving, and failure to wear helmets. He also added that driving while intoxicated can lead to serious consequences, stressing that these rules are in place to protect both drivers and pedestrians. There was an interactive session raising several question on the two topics and was answered accordingly by the resource person.

In conclusion the resource person added that obeying laws are essentials to become a good citizen.



2) College Veng, LIKKBK

An Awareness Campaign on **Drug Awareness and Wellness Navigation, NALSA (DAWN) Scheme and Mentally Illness and Person with Intellectual Disabilities Scheme, 2024** was successfully organized at Lairam Isua Krista Baptist Kohhran Thalai Pawl, College Veng Unit on 3rd October 2025 and the resource person was **B.Lahlimpuii, Advocate** and 120 members attended the Programme.

The Programme aimed to educate and sensitize young people and the local community about pressing social issues that affect individual well-being and community harmony.

The session began with an invocation, followed by a welcome address from the church youth Leader. Resource person emphasized the growing problem of drug abuse among the youth and its devastating impact on families and society. Participants were urged to stay away from drugs, along with guidance on how to seek help and rehabilitation for those struggling with addiction.

The resource person not only talks about the importance of physical health but also talks about the importance of emotional stability and spiritual balance. The audience was encouraged to adopt healthy habits, practice self-discipline and maintain a positive outlook on life.

An important part of the campaign focused on Mentally Ill, aiming to break the stigma and misunderstanding surrounding mental health. Participants were informed about common Mental Health issues, their symptoms and the importance of early diagnosis and counselling. The speaker encourage compassion and community support for people living with mental health conditions, emphasizing that mental illness should be treated like any other health problem-with care understanding and medical attention.

The programme concluded with a question and answer session, where participants actively shared their thoughts and raised meaningful questions.

In conclusion, the awareness campaign at LIKKBKTP, College Veng Unit was a valuable initiative that brought attention to critical issues like drug abuse, mental illness etc. It served as an inspiring reminder that with knowledge, unity and compassion, the community can work together towards a safer and healthier future.





3) LADC Hall

On 20th October, 2025 the DLSA team conducted an awareness campaign at LADC Hall with Lawngtlai Auto Rickshaw Owners Association, the programme was attended by 110 members from the Auto Rickshaw Owners Association. The main aim of this campaign was to educate the Auto Drivers on Motor Vehicle Act, including NALSA Child Friendly Legal Services for Children Scheme, 2024.

The Resource person Mr. C. Lalremsanga, JMFC addresses the attendees on Motor Vehicle Act, and elaborated on the importance of following various traffic rules, and highlighting different potential penalties associated with violations, he further address various traffic violations like driving without wearing helmet, licence default, driving while intoxicated etc. He then further stressed on the NALSA Child Friendly Legal Services for Children Scheme, 2024. Stating that the Scheme is a comprehensive legal framework designed to provide accessible, effective, and child-sensitive legal aid to all children in need across India, including those with disabilities.

He then opens an interactive session where the attendees can raise their concerns towards the topics, and concluded the programme with a vote of thanks from the DLSA team.





4) Arm Wrestling YLA, Community Hall.

An Awareness Campaign on **Drug Awareness and Wellness Navigation, NALSA (DAWN) Scheme** was organized on 24th October 2025 at the Arm Wrestling Association, Lawngtlai AOC Veng. The resource person was **Vanlalhluna, Advocate** and 270 members attended the Program.

The Programme aimed to enlighten youth, sportsperson and community members about the Harmful effects of drug abuse, the importance of health and wellness and the availability of Legal aid support under the DLSA.

The event began with an opening address by the organizer, highlighting the relevance of combining sports and social awareness to promote a disciplined, drug-free lifestyle. The Campaign emphasized that athletes, being role models in society have a special responsibility to encourage others to maintain physical and mental wellness.

The Resource Person Vanlalhluna, Advocate delivered informative talks on drug prevention, the psychological and social consequences of substance abuse, and the importance of early intervention and rehabilitation. He encouraged participants to avoid peer pressure and unhealthy habits that could affect both their health and sports career.

The programme concluded with interactive discussions, where participants shared their view and experiences.

In Conclusion, the Awareness Campaign at Arm wrestling Association successfully combined the spirit of Sportsmanship with the message of health, wellness, and Legal empowerment. It serves as a strong reminder that through awareness, disciplines and compassion a healthier and more responsible society can be built.



II. Outreach

5) Saizawh Village.

On 3rd October, 2025 the DLSA team had an outreach programme at Saizawh village, where a Pamphlet containing NALSA Child friendly Legal Services for Children Scheme, 2024 had distributed among the villagers, the villagers responded with a positive feedbacks. The scheme aims to ensure children have access to a range of services, which include legal support, police assistance, medical and psychological counselling, and rehabilitation services like education and non-institutional care.



III. Victim of Crime Compensation Meeting.

The Mizoram Victim of Crime Compensation consideration meeting was held on 31st October 2025, under the supervision of DLSA. The meeting was convened to review and considered the applications for compensations submitted by victims of various crimes under the Victim Compensation scheme.

During the meeting, the members examined the cases and each case was discussed in detail to assess the eligibility and the extent of compensation to be granted based on the nature of offence, the degree of injury or loss suffered, and the financial condition of the victim or dependents.

In this meeting, 17 applications were considered in which 10 applicants were awarded for compensation while 3 applications were rejected and the remaining 4 applications were reserved for re-consideration on next sitting accordingly.



V) National Lok Adalat

The National Lok Adalat was successfully conducted on 24th October, 2025 at CJM Chamber, District Court Building, Lawngtlai where total of **12 pre-litigation cases** were

presented before the National Lok Adalat. These cases primarily involved civil matters, money recovery, and bank settlements.

Out of the total cases presented, **7 cases were successfully settled** through mutual agreement between the parties involved. The proceedings were conducted in a cordial and cooperative environment, ensuring that justice was delivered in an expeditious and cost-effective manner. The **total settlement amount** achieved during the National Lok Adalat stood at **Rs. 28,00,000/- (Twenty eight Lakh only)**, marking a significant financial resolution through consensual and non-adversarial means.



VI) Jail Visit/Legal Aid Clinic at District Jail, Lawngtlai on 31st October, 2025.

This Authority conducted Jail visit on 31st October, 2025. At the time of visit, there are 7 nos. of UTP and 20 nos. of convicts. The visiting Advocate conducted interaction with the under trial prisoners and discuss the matters relating to rights of the UTPs with the inmates. After interaction, the inmates posed many questions and were answered by the visiting Person.
