## **1. National Lok Adalat on 11<sup>th</sup> , May, 2024 at District Court Lawngtlai**

On 11<sup>th</sup> May, 2024 one bench of National Lok Adalat was constituted with 1) Jothansangi Tlau, Presiding Judge, 2) ST Ramhmachhuanmawia, Advocate 3) Laldinmawii, Social Worker as conciliators. 14 cases were taken up for hearing. Out of the total cases taken up for hearing 11 cases were disposed. The value of all cases settled at the hearing was Rs. 1,654,162/- ( Rupees Sixteen lakh fifty four thousand one hundred sixty two) only.



**2. Erection of Hoarding on the road side of, Thingkah, Lawngtlai near 71 RCC, KMMTTP/LDP (Diltlang-Parva road),DC Office Complex and near District Jail on 31<sup>st</sup> May, 2024 by DLSA Lawngtlai Staff.**

On 31<sup>st</sup> May, 2024 DLSA Staff had erected Hoarding on the roadside of Thingkah, Lawngtlai near 71 RCC, KMMTTP/LPD (Diltlang-Parva road),DC Office Complex and District Jail in order to spread Awareness for Majority of the people.



**3. Jail Visit/Legal Aid Clinic at District Jail, Lawngtlai on 31<sup>st</sup> May, 2024  
Resource Person – Shri. C Lalremsanga, Judicial Magistrate First Class.**

This Authority conducted Jail visit on 31<sup>st</sup> May, 2024. At the time of visit, there are 8 nos. of UTPs and 21 nos. of convicts. The visiting Officer/Resource Person conducted interaction with the under trial prisoners and discuss the matters relating to rights of the UTPs with the inmates. After interaction, the inmates posed many questions and were answered by the Resource Person.
