## 1) <u>Legal Awareness on "Issues of drugs abuse and de-addiction schemes/policies" held on 3<sup>rd</sup> December, 2024 at Downtown English school, Lawngtlai.</u>

On 3<sup>rd</sup> December, 2024 this authority organized an awareness campaign at Downtown English School (DES) Lawngtlai, on the topic of "Issues of drugs abuse and deaddiction scheme/policy"

The Resource person Zirthantluangi, Advocate delivered a speech regarding the key objectives of the scheme, there was an interaction between the students and the resource person and the programme was concluded with a positive feedbacks.



#### 2) <u>Observance of national Lok Adalat on 14<sup>th</sup> December, 2024 at District Court Lawngtlai.</u>

On 14<sup>th</sup> December,2024 2 Bench of National Lok Adalat was constituted with 2 Judicial Officers Jothansangi Tlau and C.Lalremsanga along with 4 Conciliators 1)H.Lalfakzuala, Advocate 2) Laldinmawii, Social worker 3) St. Ramhmachhuanmawia, Advocate 4) Vanlalhlupuii Fanai, Social worker. Out of all 40 cases taken up 11 cases were settled and 22 cases were disposed. The value of all cases settled at the hearing was Rs.2,870,000/- ( twenty eight lakh seventy thousand) only.





### 3) <u>Jail Visit/Legal Aid Clinic at District Jail, Lawngtlai on 18<sup>th</sup></u> <u>December, 2024. Resource person-Shri C.Lalremsanga, Judicial Magistrate First Class.</u>

The authority conducted Jail Visit on 18<sup>th</sup> December, 2024. At the time of visit, there are 18 nos. of UTP and 17 nos. of Convict. The visiting officer conducted interaction with the under trial prisoners and discuss the matter relating to the rights of the UTPs with the inmates. After interacting, the inmates posed questions and were answered by the resource person.
