**1) Legal Awareness on “Law Related to women” held on 23<sup>rd</sup> September, 2024 at Bethel Kohhran Hall, Lawngtlai.**

Resource Person Smt. B.Lahlimpuii ,Advocate Lawngtlai District, Lawngtlai

The program conducted on 23<sup>rd</sup> September 2024 at LIKBK Hall began with an introduction by Mr. Lalchhungliana PLV emphasizing the importance of legal awareness in empowering women and promoting gender equality.

Following this, a resource person Ms. Lahlimpuii, Advocate gave awareness on various legal aspects pertinent to women including Domestic Violence Act, Prevention of Sexual Harassment ( POSH Act) and rights of women under BNS.

This programme conducted at Bethel kohhran Hall was attended by around 70 members of LIKBK hmeihchhe pawl.



**2) Legal awareness programme for youtubers held on 24<sup>th</sup> September, 2024 at Lawngtlai Press Club.**
