**1. Observance of International Women's Day on 8<sup>th</sup> March, 2024 at LADC Hall, Lawngtlai**

This authority conducted International Women's Day on 8<sup>th</sup> March 2024 at LADC Hall, Lawngtlai. Smt. Zoengi (Vice President) MHIP Sub.Headquater's Lawngtlai was chaired the programme. Chief Guest Abraham Khithie addl. DC Lawngtlai had given a sensational speech about the inevitable role played by women in the society as well as Family. After that, Z Laldinzuala, SFL, DHEW-DPO (WCD) instantly delivered a remarkable speech on Women and Empowerment in mizo Culture. Smt. Saimawii Sailo, Protection Officer (NIC) shared an eyeopening awareness on Child Rights and its related issues by referring the roles and functions of CBO's. Smt Jothansangi Tlau CJM-cum-Secretary DLSA, Lawngtlai had given a remarkable speech on 'Women's safety and Security' and also shared about the sexual harassment of Women at workplace (prevention ,Prohibition and Redressal) Act,2013.The programme was spend with full of delighted,also 5 sub.branches had participated their items in this programme.





**1. Observance of Pan India Campaign on 3<sup>rd</sup> February, 2024 at District Jail ,Lawngtlai.**

Resource person Smt. Jothansangi Tlau, Chief Judicial Magistrate – cum – Secretary DLSA, Lawngtlai District, Lawngtlai.

This Authority conducted Pan India Campaign on 3<sup>rd</sup> February, 2024 at District Jail, Lawngtlai. The programme was chaired by shri HC. Hratlana, Superintendent, District Jail, Lawngtlai. The resource person Smt. Jothansangi, Chief Judicial Magistrate - cum - Secretary, DLSA delivered a speech on “Juvenile Justice Act” . After the speech, an interaction was held with the inmates and discussed the matter relating to their rights. After interaction, the inmates posed several questions regarding their requirement for skill development and physical activities and were answered by the resource person accordingly. The resource person indentified that there were no juvenile inmates in the Prison.



## **2. Observance of Health Camp on 5<sup>th</sup> February, 2024 at Lairam Child Adoption Centre in collaboration with DCPU, Lawngtlai.**

**Resource person Smt. Saimawii Sailo, Protection Officer , District Child Protection Unit, Lawngtlai District, Lawngtlai.**

This Authority conducted Health Camp on 5<sup>th</sup> February, 2024, at Lairam Child Adoption Centre in collaboration with DCPU, Lawngtlai. Smt. Jothansangi Tlau, Secretary DLSA Lawngtlai was chaired the programme as she then expressed her concern regarding the roles and functions of District Legal Services Authority in Child Rights. Smt. Saimawii Sailo, Social Worker, DCPU, Lawngtlai acted as a resource person and gave a short speech about the implementation of Child Protection Services at Village Level. She extended her speech on the functions of Integrated Child Protection Scheme (ICPS) in a District. A total of 25 Children were examined by Dr. C. Zarzosangi and prescribed medicines according to their needs.



### **3. Observance of Mental Health Camp for Prisoners on 14<sup>th</sup> February, 2024 at District Jail, Lawngtlai**

This Authority conducted Mental Health Camp on 14<sup>th</sup> February 2024, at District Jail, Lawngtlai.

The programme was chaired by Smt. Laldinmawii, Social Worker . The resource person Smt. Jothansangi Tlau, Secretary DLSA, Lawngtlai had given a speech about the importance of considering Physical and Mental Health in today's world .Also she mentioned that we were the first District that conducted Mental Health Camp in Mizoram .She eventually, enquired the inmates about their needs for maintaining their physical and mental health, the inmates accordingly requested her to provides some kinds of sport facilities& Music Instruments. She then requested one of the MJAs members to delivered a speech. Among the MJAs member,Mr. Lalngheta Ralte had given a short speech about how Media played an important role in a daily life he then extended his promised to handout Newspapers in District Jail,Lawngtlai atleast once a week.

After that, Dr. Zothanpari Ralte along with 2 Psychiatric nurse started examined the inmates mental as well as physical health. Out of 23 inmates, 2 inmates were found mentally ill and the others were prescribed medicines according to their needs.



**4. Observance of Skill Development Training for Prisoners on 29<sup>th</sup> February at District Jail, Lawngtlai**

As such the trainers teached how to developed their skills especially in Cutting a person's Hair. Moreover, the trainer's emphasize on when and how all the prisoners may used their skills for their Daily earnings after leaving Judicial Custody





**5. Jail Visit/Legal Aid Clinic at District Jail, Lawngtlai on 29<sup>th</sup> February, 2024  
Resource Person – Smt. Jothansangi Tlau, Chief Judicial Magistrate– cum- Secretary, DLSA, Lawngtlai District, Lawngtlai.**

This Authority conducted Jail visit on 29<sup>th</sup> January, 2024. At the time of visit, there are 18 nos. of UTPs and 19 nos. of convicts. The visiting Officer/Resource Person conducted interaction with the under trial prisoners and discuss the matters relating to rights of the UTPs with the inmates. After interaction, the inmates posed many questions and were answered by the Resource Person.
