MONTHLY ACTIVITY REPORT, DECEMBER 2025

1. Awareness Campaign 3rd December 2025



Legal Awareness Campaign was held on 4TH December, 2025. At District Jail, Champai. On the topic Observance of World Aids Day, 70 people attend this Campaign. Resource person was Upa F Lalrinawma (Accountant M&E) supported by three (3) staff members .

2. Awareness Campaign on 10th December, 2025



Awareness Campaign was held on 10TH December, 2025. At TNT, Champhai. On the topic Human Rights, Our Every Essentials, 300+ people attend this Campaign. Resource person was Lalchhuansanga Sailo (Advocate) supported by three (3) staff members.

3. Universal Health Coverage Day, 2025



Observance of Universal Health Coverage Day, 2025 was conducted on 12.12.2025 as requested by NALSA. This programme was held based on Annexure-A provided by the Scheme. Using points mentioned in the Annexure, District Legal Services Authority, Champhai distributed pamphlets under 'Non-Communicable Diseases' based on 'National Oral Health Programme' to the citizens of Champhai. Two (2) PLVs was deployed by DLSA Champhai for distribution of the said pamphlets.

4. National Lok Adalat held on 13th December, 2025



National Lok Adalat was held on 13th December, 2025. 2 Benches were constituted with 2 conciliators on each 2 benches and 2 judicial officers. 12 cases were taken up and 7 cases were settled. 6 other civil cases were settled and 1 Bank recovery were settled. Expenditure incurred was 15,07,300
