They shall be on probation for a period of 2(two) years which may be extended for good and sufficient reasons. They are also liable to be transferred anywhere within Mizoram and shall not claim transfer before completing 2 (two) years of service or confirmation.

Their appointment is subject to the condition that they should submit joining report within 15(fifteen) days from the date of issue of this order to the undersigned, and thereafter proceed to their place of posting. As per extant norms, the joining report shall be submitted with Attestation form by the candidate, police verification report, character certificate and medical certificate duly signed by a registered medical officer, failing which their appointment will stand forfeited/cancelled.
