This appeal Petition is filed U/S-3-A of Orissa Scheduled Area Transfer of Immovable Property (By scheduled Tribes) Regulations, 1956 to issue direction to Sub- Collector, Kandhamal for quick disposal of case filed in his court by the petitioner U/S-3-A of OSATIP (Scheduled Tribes) Regulation, 1956.

Contention:-

The suit land of area of Hc. 0.399R of Plot No. 398 of Hal Khata No. 120 belongs to the petitioner who belongs to ST community. But suit land is under unauthorised possession of Chief district Veterinary Officer (CDVO), Phulbani. Against the said illegal possession, the Petitioner has filed a case in VISIO the court of Sub-Collector, Kandhamal for restoration of the land in favour of the Petitioner.
