#### **Prayer**

This revision petition is filed U/S-12 of OPLE Act to correct the ROR and to record area of Ac.0.312 of plot No. 848 of Khata No. 607 of Kamalapur mouza of Kanisi Tahasil in favour of petitioner. In this case, the petitioner prays "to accept the prayer and record the land in the name of the Petitioner in the interest of justice." The petitioner has filed delay condonation petition U/S-5 of Limitation Act wherein ignorance of law has been cited as the reason for delayed filing of this revision petition. The revision petition is admitted to verify the veracity of the claim of the petitioner and field status of the suit land.





## Contention: -

Sabik land was unsurveyed in sabik status. One Ramanath Sahu sold the suit land to Prafulla Chandra Padhi (husband of petitioner) vide RSD No. 283/1975. Petitioner is a landless person and is residing with her family in a dwelling house over the suit land. During the last settlement finalised in the year, 1983, suit land was recorded as Govt. land. Hence, the petition to record the suit land in favour of the petitioner.
