The document contains the details of budgetary transfers to Local Bodies for 2017-18 (Actuals), 2018-19 (Budgeted and Revised Estimates) and 2019-20 (Budget Estimates), apart from a brief note on the 5<sup>th</sup> State Finance Commission.

#### Fifth State Finance Commission (5th SFC)

In pursuance of the Constitutional provisions and Haryana Finance Commission rules, the State Government had constituted the 5th State Finance Commission vide notification dated 26.05.2016 under the Chairmanship of Professor Mukul G. Asher to make *inter-alia*, recommendations as to the sharing of State revenues with the Rural and Urban Local Bodies and to suggest measures for augmentation of their internal resources. The Commission submitted its Report on 13.09.2017 for the award period 2016-17 to 2020-21. Major recommendations of the 5th SFC are as under: -

- Financial devolution of 7 percent of the Total State's Own Tax Revenue to Local Bodies in the ratio of 55:45 (PRI: ULBs).
- Distribution criteria based on Population and Area in the ratio of 80:20.
- Inter-se share of Rural Bodies in the ratio of 75:15:10 (Gram Panchayats, Panchayats Samitis and Zila Parishads).
- On implementation of GST, assignment of 5 percent Surcharge on VAT and Excise duty share (per bottle) to local bodies will be discontinued.
- 2 percent Stamp duty share will be continued as before to ULBs.
- Specific grants of ₹250 crore for establishment of State Level Urban Shared Service Centre and ₹70 crore for Swarna Jayanti Haryana Institute for Fiscal Management (SJHIFM).

The Cabinet Sub-Committee headed by Hon'ble Finance Minister, Haryana agreed to accept the recommendations of the 5th SFC.

The Report of the 5th SFC was laid on the Table of the Haryana Vidhan Sabha in the month of September, 2018. The Government decided to implement the recommendations of the Commission from 2018-19. Accordingly, budget provision has been made under SFC schemes as follows: -

After receiving the details of State Own Tax Revenue and actual expenditure incurred by the Local Bodies during the year 2018-19 in the Finance Accounts from the office of Principal Accountant General (A&E), Haryana, necessary adjustment of arrears/access funds will be made at the time of Supplementary Estimates or Revised Estimates 2019-20.
