Subject:-

Improving further Cadre Specific ACP structure of Haryana Police Services (HPS) Officer.

Whereas, as per Haryana Civil Service (ACP) Rules, 2016, Cadre Specific ACP has been allowed to various cadres including **Haryana Police Services** (**HPS**) in the State of Haryana and 2<sup>nd</sup> and 3<sup>rd</sup> ACP has been allowed with rider of %age except, HCMS and HCS.

The matter has been further considered at length. After careful consideration, the State Government has decided to modify the Cadre Specific ACP structure of the **Haryana Police Services (HPS).** Accordingly, in exercise of the power vested under the provision of Rule 25 of the Haryana Civil Services (ACP) Rules, 2016 and all other powers enabling the Government so to do, Cadre Specific ACP structure of the Haryana Police Services (HPS) is **herby revised/modified with prospective effect as under:-**
