Payment of Dearness Allowance@ 38% to Haryana Government employees, who are drawing their pay as per 7th Pay Commission Structure w.e.f. 1st July 2022.

The Governor of Haryana is pleased to decide that the Dearness Allowance payable to Haryana Government employees, who are drawing their pay as per 7th Pay Commission Structure, shall be enhanced from the existing rate of 34% to 38% of the basic pay with effect from 1st July, 2022. Enhanced DA shall be payable with the pay of October, 2022 and arrears for the months of July, 2022 to September, 2022 (3 months) shall be payable in the month of November, 2022.

The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
