**Subject:- Payment of Dearness Allowance to Haryana Government employees, who are drawing their pay as per 5<sup>th</sup> Pay Structure w.e.f. 1<sup>st</sup> July, 2022.**

The Governor of Haryana is pleased to enhance the Dearness Allowance (DA) payable to Haryana Government employees, who are drawing their pay as per 5<sup>th</sup> pay structure, from existing rate of **381% to 396%** of the basic pay **with effect from 1<sup>st</sup> July, 2022.**

2. Enhanced DA shall be paid with the pay of December, 2022 payable in January, 2023 and arrears for the months of July, 2022 to November 2022 shall be paid in the month of February, 2023. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
